## **Parish Precept**

The local government transparency code was issued to meet the government's desire to place more power into citizens' hands to increase democratic accountability. It was expected to make it easier for local people to contribute to the local decision-making process and help shape public services. Ironically this has increased the workload and the expenditure of the parish councils.

Hothersall Parish Council is one of the smallest in the Ribble Valley but still has to carry out the basic functions of larger parishes. Our total annual income is currently £750, this is received through the Ribble Valley Borough Council Tax Parish Precept and it has remained the same since 2005.

We have applied to RVBC to increase the precept to £1000 – this means for example a band D property would see an increase from £10 p.a. to £13.33 p.a. per household. This will be payable through their Council Tax as it is now. Please see link below for comparisons to other parishes.
