3. Community approach to bereavement services

Update led by Howard Greenoff, Catherine Millington-Sanders, Sanja Djeric Kane and Susan Van Beveren

Initiative overview: 'Healthwatch Kingston (HWK) and Kingston Voluntary Action (KVA) were commissioned by South West London Clinical Commissioning Group to undertake some research into people's experiences of bereavement services in Kingston.

A community engagement approach was taken that explored the lived experience of those accessing services/support, what mattered most when grieving and the intersection with culture, faith and language barriers. Report linked here
