24/75. Bridleway 5, Langford – Response from Highways received: 'no further action needed. We have now answered this enquiry with no planned further action.'

24/108. Flooding Witham Road - Response from Highways received: 'We have investigated and risk-assessed this issue. Our recent inspection of this issue has prioritised it as not as serious as some of the other defects we are aware of, so we have recorded it and will consider it when we are planning future works in the area. This does not mean that this issue is not important to us; we will repair it just as soon as is humanly possible given the constraints explained.'

24/110c) Water on road above Ulting Wick - Response from Flood Team received: 'Having liaised with the Highways Maintenance team, we can confirm they attended the site on 25th July to jet the pipe which is now all clear and running.'

24/00589/WTPO and 24/00592/TCA - (TPO 04/86) A1 - Group of trees - Vertical reduction by 1m and lateral reduction by up to 1m. CML Microsystems Limited, Oval Park, Hatfield Road, Langford. The Parish Council agreed that whilst up to 1m overall reduction to clear powerlines is necessary the final shape of the individual trees should be considered.

24/00580/NMA - <u>Application for non-material amendment following grant of Planning Permission</u> 22/00840/FULM (Erection of building for Sui Generis purposes, together with car parking, servicing

areas and landscaping). Amendment sought: Reduced width to office building, main entrance to office building set back, colour scheme amended, glazing and shading design modified, warehouse door/dock leveller positions moved, processing area door positions moved, minor interior layout changes, external works revised, roof design and parapet modified. Maldon Salt, 2 Oval Park, Hatfield Road, Langford This was noted by the Parish Council.

24/00569/FUL - Erection of 3 storey, 66 bed care home for older people with associated landscaping, car parking and access.

□ Land At Broad Street Green Road And Langford Road And Maypole Road Great Totham

The Parish Council agreed to object to the proposal on the basis that this three-storey building is of too great a mass to fit in with the street scene. Concern was raised for the accessibility and safety of residents, and the lack of outside amenity space.
