# 23/01. Apologies for absence

# 23/04. County and District Councillor's reports

Cllr. Morgan reported the following:

- A proposal to reduce the number of Planning Committees from three to one, at a recent full MDC meeting, was not successful.
- There is a growing move to devolve services provided across neighbouring Councils to maximise efficiencies.
- Funding approved for new Environmental Health Officer.

The Chairman thanked Cllr. Morgan for attending the meeting. Cllr. Morgan then left the meeting.

#### 23/05. Public Question Time

A resident asked where the Parish Council precept came from. It was noted that this
is included in the Council Tax paid by residents to Maldon District Council.

#### 23/06. Matters for information from previous meetings

22/166e) Section 106 contribution – The clerk had emailed JTS Partnership to request a contribution towards replacing the streetlights. Request had been passed on to Maldon District Council.

22/168. Streetlights – It was noted that the clerk had managed to get two quotations. The other suppliers are currently not taking on new business contracts. Clerk to confirm with SSE, why kWh used in contract differ from the Unmetered Supply Certificate.

22/169. Newsletter quotations – The Chairman was awaiting a further quotation.

- 22/171. Local Highways Panel requests Clerk had resubmitted requests for the following: a) Reduction in speed limit from 60mph to 40mph between the Langford village gateway.
- Hatfield Road and the Ulting village gateway near Elm Cottages, Hatfield Road.
- b) Reduction in speed limit to 30mph between the village gateways (B1019) and the 40mph speed limit sign in Witham Road (B1018). It was noted that both were in validation on the Awaiting Funding list.

**22/01099/ADV** - The temporary display of advertisements comprising; 3 No. freestanding non-illuminated flagpole adverts, 1 No. double-sided free standing non-illuminated advert and 1 free-standing non-illuminated single sided advert, Land At Broad Street Green Road And Langford Road And Maypole Road, Great Totham was approved **22/00933/FUL** - Conversion of redundant grain store (Building B) to create 2 no. residential units, Outbuildings Stock Hall Farm, Hatfield Road, Ulting was refused.
