21/66. Neighbourhood Plan update – Examiner procurement – Request to score candidates received. Cllrs. Anfilogoff and Allen and clerk to liaise.

21/63. It was noted that clarification on the curtilage of an agricultural building permitted to change to a dwelling under Class Q had been received. Response received was as follows: The curtilage is subject to the stipulation that the area of land beside the building for the garden/amenity space shall be no larger than the area of land occupied by the building. If the land beside the dwelling was proposed to be enlarged at a subsequent date then planning permission would be required to enlarge the garden/amenity area.
