1. Minutes of the last Annual Meeting – 18th April 2017

2. Matters Arising.

3. Chairman's Report.

- a) Ditches The surveying and mapping of ditches in the Parish had continued and was almost finished thanks to the sterling efforts of Jenny Clemo and Irene Allen.
- b) Grasscutting The Chairman thanked Colin Ashby for cutting Langford churchyard, John Clemo for keeping the ford tidy and Alan Marks for keeping the Ulting Lane green looking smart and well-tended.
- c) Newsletter The Chairman thanked Irene Allen who had produced three extremely good and lively village newsletters to a very high standard. This is being financed by the Parish Council.
- d) River bridge Highways had repaired the damage caused by a car colliding with the bridge.
- e) General Data Protection Regulations The clerk had been preparing the necessary documentation for the new protocols. The Chairman thanked her for this and for her continued sterling work as clerk.
- f) Planning The village trigger has been withdrawn by Maldon District Council and parish councils no longer receive paper copies of planning applications. The Parish Council is keeping a watching brief to ensure that the same levels of engagement by are maintained.
- g) Neighbourhood Plan The Parish Council intention is to get some sort of plan out of the process. It would have saved a lot of time, hard work and frustration if in 2016 when we had the Inspector's Report someone had just said to us 'go with this you'll never get a housing policy'.
- h) General permitted development Several conversions of disused farm buildings have been allowed in the parish. Unfortunately, these are not always in appropriate locations and do not have to pass the sustainability test.

Finally, the Chairman thanked Henry Bass for his continued support and Mark Durham and though it is obviously increasingly difficult for him to attend meetings due to his commitments at ECC, he is addressing this by posting a blog on You Tube.
