22/77. County and District Councillor's report

Cllr. Morgan reported the following:

- Council Statutory Annual meeting held last week Cllr. Boyce elected as Chairman
- Westcombe Park Reserved matters application was approved. First phase, 120 homes, to be completed by June 2023
- The Essex Serpent had been filmed around the District
- Homes for Ukraine To date there have been 1021 requests for accommodation and 759 sponsors in Essex

22/78. Public Question Time

- Otter fencing round fishing lakes Residents had been appalled but this had become an issue since otters had returned to Essex.
- Ulting Sign It was noted that the sign would be installed before the Queen's Platinum Jubilee and there would be an unveiling ceremony. Date to be advised.
- Litter bin at Beeleigh It was noted that there had been a bin but due to constant vandalism it had not been replaced.
- Dead elms, Crouchmans Farm Road Clerk had notified Highways.
- Village Hall It was noted that high speed broadband had been installed by County Broadband free of charge and is now up and running.
- Crouchmans Farm Road junction with Bumfords Lane A resident had made many complaints to the Environment Agency and Maldon District Council regarding sewage smells here. An Environmental Health Officer had visited the site but the issue has not been resolved.

The Parish Council agreed to support this application because the proposal Increased family living space. It was noted that Barn A would be removed if planning permission was granted and that a section of the roadside boundary has an established hedge **22/00388/FUL** - Construction of a new fish pass at Langford Sluice. Land North Of Langford Mill, Maldon Road, Langford. The Parish Council agreed that no comment was required.

At this point five members of the public and Cllr. Morgan left the meeting.

22/00559/HOUSE - Proposed rear dormer to second floor. Hillcrest, Crouchmans Farm Road, Ulting. The Parish Council agreed that a comment suggesting that the proposed dormer be rendered would be submitted.

At this point three members of the public returned to the meeting.

22/00094/LBC - Conversion of existing garage and granary buildings to form new gymnasium. games room and rest room. Changes to fenestration. The Cottage, Ulting Hall, Ulting Hall Road, Ulting. Listed building consent granted.
