Police Rural Engagement Team

PC Owen Griffiths spoke about the Team's role which includes theft of plant, hare coursing, badger baiting, heritage crime, large scale fly tipping, rural road safety, unlawful encampments and cable theft. The team of one inspector, two sergeants and ten officers covers the whole of Essex. They are part of the local Policing Support Unit and also give advice and guidance. Essex & Suffolk Water Investment Programme

Daniel Wilson explained the reasons why ESW are planning to construct a new pipeline to transfer water from Layer-de-la-Haye Water Treatment Works to the existing storage reservoir at Langford Water Treatment Works. The pipeline is to be constructed along an optimised route following consultations with land owners, the completion of ecological surveys, ground investigation work etc. The route is mainly through agricultural land and construction work affecting the B1019 is to be scheduled to coincide with the installation of the new Westcombe Park roundabout.
