23/175. Apologies for absence

There were no apologies of absence given.

23/176. Minutes of the previous meeting

The minutes of 17th October 2023 having been previously circulated were taken as read, agreed and signed by the Chairman.

23/177. Declarations of Interest

23/178. County and District Councillor's report

Cllr Simon Morgan reported a motion to withdraw the district planning committees had been put forward to the full council and then withdrawn. It was noted Maldon District Council needed to make budget savings of £600,000 by 2025 and the withdrawal of the planning committees was one of the options under consideration.
