24/157. Double Yellow Lines / Clearway - Hoe Mill

Application to extend the double yellow lines, and request for a solution to the continuing highways safety issues had been submitted. Cllrs Durham and Morgan supported this. Next partnership meeting with SEPP and MDC 6th November.

It was agreed to pursue another application to ECC Highways to extend the speed restriction through Langford as previously and reduce to 30mph through the centre of the village. Cllr Morgan pointed out that accident mitigation can be the key to this. A resident had volunteered to coordinate a petition.
