The council voted to co-opt James Loton to the council and the Declaration of Acceptance of office was duly signed.

24/25.062 Clerk's report

Precept demand has been submitted to Basildon Borough Council. Local Plan response has been submitted.

Bollards – Essex Highways will not allow for the placement of bollards of any kind on the verges. Cllr. Cooper explained that this only applies to land adopted by Essex Highways. The land around the war memorial is not adopted by Essex Highways.

Devolution – The Clerk explained that Essex County council have written to the Government to request that Essex County council, Thurrock and Southend be part of the Devolution Priority Programme and for the elections due in May 2025 to be deferred. Should the Government agree to this request the plan would be for Mayoral elections in May 2026 with the Mayor effectively taking over the role of the Police Fire and Crime Commissioner. Essex County Council, Thurrock and Southend would then be replaced by a Mayoral Strategic Authority. Several Unitary Councils would be created (3 or 4) and the existing County, District and Borough councils would no longer exist.

What the implications of this are with regards to the Local Plans currently in place or in the process of being put in place is not known.
