The tag must include your surname, full address and telephone number. The number of animal wardens is reducing and this additional information means that if somebody finds your dog they will know where to return it straight away.

Please also remember that if you have a change of address to make sure that you update the microchip details immediately and also make sure that you purchase a new tag.

# Cloghams Cricket Club - Rebuild of Club House

When the clubhouse was re-opened in March, winter had taken its toll. The thatched roof which had been on for over 25 years had leaked everywhere. The ceiling had fallen down in many places and the walls were stained and damaged by the rainwater.

After costing the work it was sadly apparent that it would need far too much money to replace the thatch, so it was decided that to replace the roof using the skills of several club members.

The picture below shows the roof during the stripping process. Once the straw had been taken off it was discovered that various pests had got into the rafters and several had been affected with wet rot.

It was interesting to find, as shown in the photographs, that the roof had been built many years ago by forging tree trunks to make the rafters.

All work is scheduled to be completed by the end of June.

Meanwhile cricket continues with good results so far. After 6 fixtures, won 4, lost 1, no result 1. Cloghams are 5th.

Already Robert Crouchman has hit 3 centuries in trying to retain his award of highest run scorer from last year. Let's hope these positive results continue.









#### 14. ANY OTHER BUSINESS

- 14.1 The Clerk reported that launch of DigiGo a new bus service for all residents in Uttlesford and other districts where residents can book the bus either online, by telephone or via an App which can be downloaded. The transport provided is one of the first fully, on-demand electric minibus services in the UK.
- 14.2 The clerk reported that between meetings it was reported to her that a drain cover had been stolen from the road in Lordswood View causing a hole large enough for small children or pets to fall into. Once reported the drain was temporarily repaired within an hour to ensure there was no danger incurred and fully repaired within two weeks.
- 14.3 Between meetings a resident contacted the clerk to clarify the dates for the fortnightly green skip visit to the school on Sundays as, when comparing the dates, they were different on the village website and the Parish News. It was found that the dates published in the Parish News were incorrect but as the clerk does not publish the dates in the Parish News, she will look into how to make them correct. She assured the resident the dates on the website, the village notice board and those published in the Leaden Reading are correct.



## **Essex Rangers**

There are minor improvements that could be made to the highway across the County that are not necessarily highway defects and would not meet the maintenance criteria but that would make a huge difference to the appearance of the local area. These types of works are best carried out by the Highway Ranger Gangs, typically consisting of two people and a van. The Highway Rangers Service is dedicated to provide practical support to the LHPs. The Service is funded through the ECC Revenue Budget and is carried out either directly, via Essex Highways, or in Partnership with the Borough, City or District Council.

Sadly Leaden Roding Parish Council have been informed that the Uttlesford Rangers Team are regularly receiving criticism and on occasions abuse when they visit villages. For many years Uttlesford Rangers have provided a solid and professional service and we are lucky to have such a skilled and dedicated team representing the district so it is a shame when they are faced with such negativity when going about their jobs.

The Parish Council would like to politely request that residents be courteous and respectful all contractors as they go about their jobs in our village.

## 11. PLANNING APPLICATIONS

11.1 The following planning application was circulated to Parish Councillors between meetings for comments:

St Michael and All Angels Church, Stortford Road – Sections 73A Retrospective application for the replacement of collapsed shed with a converted container storage facility with the proposed installation of a community toilet – *no objections*.

11.2 The following decisions to determine the following planning application was made between meetings:

New Cottage, Dunmow Road – Proposed erection of 1 detached dwelling including alterations to existing vehicular access – <u>refused</u>

- 11.3 Between meetings more concerns regarding building work/preparations were brought to Uttlesford's attention after a 'Prior Notification' was brought to the Parish Council's attention for Barn adjacent to Chalks Farm, High Easter Road. Uttlesford have informed the clerk that the situation is being monitored with a representative visiting the site, unfortunately they could not gain access at the time of the visit.
- 11.4 The decision has been made for following planning application subject to an appeal to Inspector appointed by the Secretary of State has been made:
- 3 Leaden Hall Barns, Stortford Road erection of an additional external storage building <u>refused.</u>

#### 12. FOOTPATHS

12.1 In a statement to be read at the meeting, Cllr Sutterby reported:

The following issues are still outstanding.

Footpath 1 - bottom of Longsted Lane, the footbridge detached from concrete base (defect number 3523027).

Footpath 5 – bridge over river Roding in need of repair – this work was due to commence on 6<sup>th</sup> May (defect number 3213425).

## 13. MEETING WITH CLLR LEE SCOTT HIGHWAYS

- 13.1 Due to unforeseen circumstances the Chairman was unable to attend this meeting with the clerk so Cllr Bush took his place. The clerk reported:
- Cllr Scott stated he was determined to improve the process of repairs after issues have been reported to Highways with any dangerous issues taking priority. He stated that due to financial constraints any cosmetic issues will be of low priority.
- He stated any emails sent to him with regard to Highways issues will be dealt with swiftly and he will reply promptly.
- Speeding is a priority; Cllr Scott has instigated a team of Highways Officers to be able to conduct speed
  checks and legally issue speeding fines and points: this will take place imminently and regularly across the
  county.
- Flooding on the Highways will also be a priority.
- He is aware that new building developments cause issues with road surfaces and flooding and is looking into the possibility of charging a Bond to all new developments in Essex where it will be returned to the developer once the development has been finished only if the roads on and adjacent to the site are left as they were before the building work started.
- Cllr Scott stated that when he took over as the representative for Essex, there was only one Highways Enforcement Officer employed to oversee the whole of Essex. Now more Enforcement Officers are in place across the county to oversee any Highways issues.
- He is aware that large vehicles driving through country lanes are damaging the roads and is looking into asking Google Maps to exclude small country lanes from any Satellite Navigation routes.
- Cllr Scott stated he is aware that not all residents affected by Ride London are happy for Essex to host the event. He will be hosting more meetings before the event and will be happy to take answer any comments/criticism or feedback.
- Cllr Scott finished by stating he is looking forward to working with Parish Councils in the future to improve their experience when dealing with Highways issues.

9.8 Field opposite the school—a resident clearly remembers a footpath to the right of the field in the past—at a previous Parish Council meeting it was reported that Cllr Wareham found that public footpaths cannot be changed unless it has been agreed with the County Council or Central Government. Cllr Barker referred this to Public Rights of Way for advice and was told there was never a footpath at the location. As the resident was adamant a footpath was there years before, Cllr Barker will seek further information—no further information received at this time.

- 9.9 At the last meeting the clerk was asked to get in touch with the headmaster of Rodings School to express concerns a resident reported when witnessing a child crossing Dunmow Road alone while the parent was not paying attention, since then the clerk witnessed a smilar incident herself at the same spot. The clerk has tried to contact the headmaster to as request he asked parents to be more vigilant when taking/collected their children from school but has not yet had a reply.
- 9.10 Cllr Barker has confirmed that the request for the speed limit of 30 mph on Dunmow Road to be extended is awaiting approval.
- 9.11 The Chairman reported in a statement to be read at the meeting that parking by cars on the pavement from the car showroom is still proving a problem periodically. Cllr Wareham stated he has recently witnessed a resident with a pram having difficulty walking on the footway at the car showroom due to vehicles parked on the pavement. After discussion it was decided that any photographic evidence of cars blocking the footpath outside the car showroom and shop will be reported to the police.
- 9.12 Due to illness the defibrillator training evening book at the village had was cancelled at short notice, it will be rearranged shortly.
- 9.13 The damaged village sign outside Bridge Cottages, Stortford Road previously reported to Highways has not yet been fixed.
- 9.14 Flooding on Ongar Road discussed at the last meeting cleared once the farmer of the field adjoining the road cleared the ditch.
- 9.15 The damaged sign outside the fire station which has previously reported to Highways has been examined three times by Highways representative but not yet been fixed.
- 9.16 After accepting the quote from J Kenney for work to be carried out to clear overgrown trees, hedges, concrete and debris from the grass verge starting opposite the roundabout and finishing at the church on Stortford Road, the work commenced but had to be stopped for a resident's safety when he stood in front of the heavy equipment in an effort to stop the work as he did not agree it needed to be cleared. After discussions with the resident, where the resident became aggressive and abusive, the Chairman agreed to stop the work, Parish Councillors will discuss at the next meeting if work further down Stortford Road should be recommenced. Fortunately, J. Kenney charged the Parish Council for the work that had been done and not for the full quote. J. Kenney Services stated on the invoice:

Unfortunately, due to the fact that I was not able to complete the works as per my original quotation with regard to clearing back vegetation and making the verges clearer, and tidying them of roots, concrete and debris, and subsequent comments that it would possibly allow travellers to park, and my Staff being abused verbally by a member of the public I feel it better that I invoice the Parish Council for work done to date and I will not complete the entire job. This is the first time that this has happened since I started my company in 1989, and I am bitterly disappointed but trust you all appreciate my concerns regarding the criticisms coming our way. I charged for the part clearance works you see

Parish Councillors present expressed their disappointment that J Kenney Services were subjected to this behaviour and have apologised to Mr Kenney and his staff.

9.17 A meeting organised by Cllr Barker to discuss arrangement made for the Ride London event on 28<sup>th</sup>/29<sup>th</sup> May going through the village took place at Leaden Roding Village Hall which was open for residents of Leaden Roding and surrounding villages to attend. Councillors and the clerk who were present at the meeting expressed their disappointment at the lack of respect addressed to the representative of Ride London by some residents of Leaden Roding and others who attended.

## I can't find a service?

We are working hard to identify as many local health and wellbeing services as possible – but if something is missing or you can't find a service you need – please get in touch via email at info@frontlineuk.org.uk.

## If I request a call back or I'm referred through the system – when should I expect to be contacted?

We ask services to contact people within 3 working days, but we hope it will be quicker than that. If we see that you haven't been contacted within 6 working days we will contact the service on your behalf and chase them up.

## Are my details on the system safe?

We had a lot of help from Information Assurance officers in the NHS, EPUT and Essex County Council to ensure the system is as secure as we can make it. We only ever collect information from you to make a good referral, we only hold your data for a maximum of 90 days, and we use the same level as encryption as on-line banking services. If you want a copy of any information held on the system under your name, please make a 'Subject Access Request' to info@frontlineuk.org.uk.

### Who runs Frontline?

Frontline was designed by Uttlesford Citizens Advice, but it is really a large community project where organisations and services sign up to improve people's knowledge and access to local services. Frontline in west Essex is funded by Essex County Council and the NHS's West Essex Clinical Commissioning Group. Uttlesford's Council for Voluntary Services is helping to run the services.

## I want to give some feedback on a local service - how would I do this?

Great! Good and bad feedback is really important to understand and improve local services. It can also be used to help funding arguments and identify gaps in services. We collect feedback in various ways – you can give a service a thumbs up or down through the website or via our mobile app. If you have been referred by an organisation, and agree to give service feedback, we may contact you via email or over the phone.

This was seconded by Cllr Wareham and carried unanimously.
- 6.3 Allison Ward, the Clerk for High Easter Parish Councils is completing the internal audit, her report will be circulated, and any points considered.

#### 9. CLERKS REPORT

- 9.1 The clerk reported that the organising of the celebrations for the Queen's Diamond Jubilee is continuing with representatives from the Parish Council, Village Hall Committee and Social Club Committee making final arrangements. The clerk will print leaflets for every household and will be delivered nearer the time by the organisers. The Jubilee Beacon has been delivered and a deposit has been made for the ice cream van to be in attendance (see invoices Finance below), a large Jubilee celebration cake, bunting, children's games and prizes have also been ordered. The clerk will pay all invoices from Parish Council funds and then split the final total between the three committees.
- 9.2 Damaged soakaway at the corner of Dunmow Road and Holloway Crescent not yet fixed, the clerk has reported again.
- 9.3 Damage to footpath at entrance to Holloway Crescent by Finale driveway the clerk will report again.
- 9.4 Blocked drains outside 10 Holloway Crescent have been reported unclear whether the drains have been cleared the clerk will find out.
- 9.5 The clerk has asked that Uttlesford remind residents of Holloway Crescent not to park on entrance road to Willow Green as it obstructs access for emergency vehicles this has been monitored, it appears that an ambulance would definitely be able to gain access and a fire engine, although tight, would also be able to gain access.
- 9.6 During a meeting with Cllr Lee Scott, Councillor of Highways attended by the clerk and Cllr Bush (see below for full report), the clerk explained that a VAS sign approved by Highways for Dunmow Road was included in the Local Area Panel projects budget about two years ago and was then removed stating that there was nowhere to place the VAS sign as the footpath on Dunmow Road is too narrow. Recently the Parish Council has been advised by the same Highways Officer that a VAS sign can be installed at the same site at the expense of the Parish Council. The clerk stated she would like to know why the original approval for the financing of a VAS sign for Leaden Roding was deleted. After the meeting Cllr Barker provided Cllr Scott of written evidence. Cllr Scott will look into why the original request was deleted from the Local Area Panel list and will also look into whether Highways are able install a VAS sign on the Parish Councils behalf and if so, the cost (if Highways do not relist this to be installed at their expense).
- 9.7 After confirmation that local police officer Russ Hinkins would be attending tonight's Annual meeting, the clerk will make enquiries as to why he did not attend.

#### 6. GRASS CUTTING REPORT

John Kenney took over the grass cutting contract for the first time this year and Parish Councillors are pleased with his work throughout the village. ### 7. PARISHONERS QUESTIONS AND COMMENTS

A resident attended the meeting to address concerns to local Police Officer Russ Hinkins who was due to attend the meeting. Unfortunately, PC Hinkins was unable to attend without much notice. The clerk will pass the resident's concerns on to Essex Police:

There have been two instances when a vehicle owned by the resident has been vandalised by having ball bearings fired at the windows. The first instance was in March 2020, although reported to the police with a request for somebody from Essex Police to attend nobody did. The second instance was in October 2021 after the window had been repaired, , this was again reported to Essex Policer, at the time the resident requested that the police request from the fire service any CCTV footage they may have as the vehicle was parked nearby but footage was to far away to be clear. On 4<sup>th</sup> December 2021 the resident received a telephone call from a member of the police giving her advice on security but although a member of the forensic team attended the sight the resident did not receive any visits from Essex Police regarding the vandalism and she stated she thought this to be very unsatisfactory. She stated that a large percentage of council tax is taken to fund Essex Police and she felt the village was not getting value for money. She would like the Parish Council to make a suggestion that there should be a Police office located nearer to the Rodings so that crime in this area can be dealt with in a more efficient and timely man-

The meeting closed at 8.20pm.

## Welcome to our new e-newsletter from our Recycling Team.

You are receiving this email as you previously signed up for one of our Waste & Recycling e-newsletters.

This is a regular feature to keep you up to date and includes information and advice from other trusted sources, in addition to any changes to your waste and recycling collections.

## The importance of clean recycling





Contamination of your recyclables happens when incorrect items are placed in your recycling bin.

When this is not identified at point of collection it can cause an entire lorry load of good, clean recycling to be rejected. Where spotted, we may not collect your recycling in order to prevent contamination of the entire lorry load.

Unfortunately, during COVID-19 the contamination levels within household recycling bins increased – and is continuing to be of concern.

Recycling charity <u>Wrap</u> estimates a tonne of contaminated recycling costs around £93 to dispose of. With an average lorry load of recycling weighing approximately 5 tonnes, each contaminated load of recycling costs the council over £460.

The most common things that are wrongly put into recycling bins are black bin bags, nappies, food waste, textiles and electrical items.

Please help us reduce contamination by checking what can and cannot be placed into your green lidded recycling bin.

## Top 5 ways to cut down on food waste

- Check the use-by dates of fresh food when you buy it these are the dates to take notice of, rather than the best-before dates. Only buy what you can use before it expires
- Plan ahead think about what you're going to cook and how you'll use the leftovers

- Love your freezer use your weekends to batch-cook and freeze

Thankyou to our part time fire service for looking after the village and surrounding area. Thankyou to the residents who help with litter picks. Thankyou to the Councillors for their support through the year and also to the Parish Clerk. Thankyou to Cllr Susan Barker for advice and help through the year.

#### 5. FINANCIAL STATEMENT 2020/21

The receipts in the year were the £6,500.00 precept and £193.00 VAT refund, outgoings were slightly less - £5,779.13. An outstanding invoice of £320.00 for the last financial year for the printing of the Leaden Reading would have increased the outgoings to very close to the precept amount.

The Parish Council issued two donations in the year; it was decided to once again donate £25 as a prize for the Christmas lights competition which has proved popular in the last couple of years; another donation of £25 was made as a thank you to Leaden Roding firefighters who gave a public demonstration free of charge on how to use a defibrillator

Fixed assets remain at £23,272.

## 11. RIDE LONDON – WEEKEND OF 27<sup>TH</sup> TO 28<sup>TH</sup> MAY 2022

- 11.1 The Clerk has spoken to one of the organisers of Ride London and reported the following details:
- On both days the race/ride will go through Leaden Roding causing road closures.
- On Saturday 27<sup>th</sup> it is the ladies' elite race which will cause rolling road closures throughout the route of the race and it is expected that the road through Leaden Roding will be closed between 12pm and 1pm for approximately 20 minutes.
- On Sunday 28<sup>th</sup> May the event is a family ride with a bigger impact on the roads which will be closed for most of the day. At this time, it is expected that the road through Leaden Roding will be closed at approximately 7.00am and will reopen at approximately 3.00pm.
- The event is definitely going to take place. Essex County Council have agreed to host the event without public consultation.
- Negotiations are taking place for the event to be televised.
- The family ride is expected to raise £12,000,000 for charity and is at no cost to the tax payer. It is also expected to bring trade to local businesses along the route.
- Leaflets with information about the weekend closures will be delivered to every household on
  the route but not to the homes on the side roads off the village. The Parish Council can ask for
  more leaflets to deliver ourselves if we feel the event has not been advertised enough beforehand.
- Over the weekend before the event, representatives will tour the route leaving leaflets on cars
  parked on the route explaining that the cars will be removed if they are parked there the following weekend.
- The only route out of Leaden Roding when the roads are closed are from High Easter Road.
- The organisers are happy to host a meeting nearer the date to discuss the event if the Parish Council think necessary
- The Ride London website can be accessed to gain more details and will continue to be updated as more information is advertised.

## 12. CLEARING OF SHRUBS/HARDCORE/RUBBISH FROM GRASS VERGE FROM BROWNLOWS CLOSE TO OPPOSITE THE CHURCH – STORTFORD ROAD.

12.1 The clerk presented a quote from J Kenney Services of £4,280.00 for:

Cutting back the overhanging vegetation and scrub around the area opposite the Village Shop, back to the main hedge line. Clear all arisings and rotovate, stone bury and return the ground back to grass, including seeding throughout. Clear the roadway along to the houses from the bend of all the debris laying in the grass from the currently cut grass to the fence boundary. Removal of all arisings, rotovate and level and reseed throughout. From the houses to opposite the Church, cut back the overhanging vegetation hard to re-establish the verge, again to be prepared and seeded. If accepted the work could be carried out in mid-March.

After consideration it was unanimously decided to accept the quote. The clerk will contact J Kenney Services to arrange a date to start.

## 13. ANY OTHER BUSINESS

- 13.1 The Clerk has reported to Highways the damaged sign outside Bridge Cottages, Stortford Road which appears to be caused by the recent high winds.
- 13.2 Cllr Mclintock reported that Ongar Road approximately 100 metres from the junction of Stortford Road is flooded with rain water appearing to be draining onto the road from adjacent fields. It appears the landowner has been examining the problem so hopefully it will be resolved soon. The clerk will monitor the flooding and report to Highways if necessary.
- 13.3 The clerk reported that she has received notice from Highways Streetwork Team of the intended closure of Wash Road, due to commence on 16<sup>th</sup> March for 3 days. The closure is required for the safety of the public and workforce while Gigaclear undertake repair ducting.
- 13.4 The Chairman reported a Highways sign by the Fire Station blown down during the recent storm.

## New on-demand electric minibus service for residents in the Uttlesford, Braintree and Chelmsford area including LEADEN RODING

Residents in Uttlesford, south Braintree and north-west Chelmsford areas can now access an exciting on-demand, fully electric minibus service called DigiGo.

One of the first of its kind in the country, the service responds to demand rather than having set routes, with minibuses able to divert on and off journeys for passenger collection and drop off.

DigiGo connects rural communities in north Chelmsford, including Felsted, Little Dunmow, Barnston, **Leaden Roding**, Good Easter, Pleshey, Great Waltham, Little Waltham and Great Leighs to popular locations such as Chelmer Valley Park and Ride, Broomfield Hospital, and Writtle University College.

Meanwhile, the service in south Braintree connects villages, including Great Notley, Black Notley and Rayne, to Braintree Bus Interchange, Braintree Railway Station, Braintree Community Hospital, Springwood Industrial Estate, Great Notley Country Park and many other locations.

The new service operates seven days a week, from 7am to 10pm and caters for everyone; students, families, the elderly, and people travelling to work, with accessible minibuses available for people with disabilities, providing a flexible and environmentally friendly service for people who do not live close to public transport routes.

To book an on-demand journey, residents can download the TravelEssex planning app via their phone's app store or visit <a href="www.digigo.uk">www.digigo.uk</a>. After ordering, passengers can pay for their journey via the app and track the location of their minibus in real time. Tickets for the service can also be pre-booked up to seven days in advance.

It's easy to book a DigiGo journey via the TravelEssex app.

Book - Select your pick-up and drop-off points within our operational areas and pay on the app.

Track - Watch on your smartphone as your designated vehicle makes its way to you in real-time.

Ride - Hop on and off you go!

A journey can be booked to travel on-demand or up to 7 days in advance. Bookings are made and paid for on the TravelEssex app, where you can also track your vehicle in real time before and during the journey. All DigiGo drivers are enhanced DBS checked

- 9.2 Between meetings a 'Prior Notification' was brought to the Parish Council's attention for Barn adjacent to Chalks Farm, High Easter Road, although the Parish Council had not been given details by Uttlesford, the Parish Council was given the opportunity to give comments. Parish Councillors' comments were:
- Leaden Roding Parish Councillors have concerns regarding the entrance / exit to the property as it is directly on a blind bend as you come into the village. Although the application states "existing entrance / exit", could you please look into when this entrance/exit was approved as for many years there did not appear to be an entrance there at all but since the land has been made ready for development the owner has installed a gate and has taken the shrubbery away to widen the access. Although the piece of land is just within the 30mph limit Parish Councillors think it would prove very dangerous to exit plot.

#### 10. FOOTPATHS

10.1 Cllr Sutterby reported:

The following issues are still outstanding.

Footpath 1 - bottom of Longsted Lane, the footbridge detached from concrete base.

Footpath 5 - Leaden Hill, timber is rotting on the bridge over the river (ref 2711562).

Cllr Barker will continue to look into both issues as they have been outstanding for some time.

- 7.1The clerk reported the first meeting to organised village celebrations for the Queen's Diamond Jubilee has recently taken place. Representatives from the Parish Council, Village Hall Committee and Social Club Committee were all in attendance. It was decided to organise a bring-your-own evening picnic on Thursday 2<sup>nd</sup> June from 4.00pm. An ice cream van will be in attendance to serve a free ice cream to all attendees, there will be live music, a Jubilee cake to be shared, games, the bar will be open, teas and coffees will also be available. The evening will finish with the lighting of a Jubilee Beacon at 9.45pm. The clerk will pay all invoices from Parish Council funds and then split the final total between the three committees.
- 7.2 Damaged soakaway at the corner of Dunmow Road and Holloway Crescent not yet fixed, the clerk to report again.
- 7.3 Damage to footpath at entrance to Holloway Crescent by Finale driveway reported but not yet repaired
- 7.4 Blocked drains outside 10 Holloway Crescent have been reported but not yet cleared.
- 7.5 The clerk has asked that Uttlesford remind residents of Holloway Crescent not to park on entrance road to Willow Green as it obstructs access for emergency vehicles this will be monitored.
- 7.6 The clerk has enquired as to whether Highways are able install a VAS sign on the approach to the school on Dunmow Road and if so, the cost no reply at this time.
- 7.7 The clerk has requested that the 30mph signs on Dunmow Road be extended further towards Aythorpe Roding. Cllr Barker has confirmed this has now been submitted to the Local Highways Panel for consideration.
- 7.8 The clerk confirmed that local police officer Russ Hinkins will be attending the Parish Council's Annual meeting on 17<sup>th</sup> May to discuss concerns/answer questions on police matters. The clerk requested that Parish Councillors email her any questions they have for him so she will collate and pass on to PC Hinkins in advance so he can research any answers if necessary.
- 7.9 Field opposite the school, a resident clearly remembers a footpath to the right of the field in the past—at the last Parish Council meeting it was reported that Cllr Wareham found that public footpaths cannot be changed unless it has been agreed by the County Council or Central Government. Cllr Barker referred this to Public Rights of Ways for advice and was told there was never a footpath at the location. As the resident was adamant a footpath was there years before, Cllr Barker will seek further information.
- 7.10 Between meetings the clerk was emailed from Uttlesford, a list of dates for 2022 Green Skip visits. This year the visits are proposed for 30 minutes every 2 weeks instead of the monthly visit for an hour as in previous years. As Uttlesford requested an acceptance of

## LEADEN RODING PARISH COUNCIL

MINUTES OF THE PARISH COUNCIL MEETING held on Tuesday 8<sup>th</sup> March 2022 at Leaden Roding village hall.

**Present:** P.Sutterby (Chair), M.Whitehead (Vice-Chair), Mrs Bush, J. Mclintock, D.Wareham and District Councillor Susan Barker.

## Members of the public: 2

- 1. APOLOGIES FOR ABSENCE
- 2. DECLARATIONS OF INTEREST FOR THIS MEETING None
- 3. MINUTES
  - 3.1 The minutes of the Parish Council Meeting of Tuesday 11<sup>th</sup> January 2022 were proposed by the Chairman as a true record, seconded by Cllr Bush and carried unanimously. The minutes were signed by the Chairman.
- 4. PUBLIC QUESTIONS/CONCERNS
  - 4.1A resident expressed her concerns when she witnessed a parent who had collected a young child from Rodings School walking a fair distance in front of the child, then without looking at the child, crossed Dunmow Road with the child doing the same at a distance behind him, the resident was very concerned that if there were cars in the vicinity an accident would have occurred. The Chairman asked the clerk to contact the headmaster to express these concerns and ask if he would request that parents be more vigilant with regards to road safety when dropping off or collecting children.
- 5. DISTRICT COUNCILLOR'S REPORT
  - 5.1 Cllr Barker was very pleased to report that 2 local landowners have dug up to 6 feet of ditches by the church searching for drainage pipes to try to alleviate the flooding problems on Stortford Road. The work they have done appears to have resolved the flooding problem at this time. The clerk will email the landowners to thank them.
  - 5.2 Cllr Barker stated that an application for an extension of the 30-mph speed limit on Dunmow Road towards Aythorpe Roding has now been submitted to the Local Highways Panel.
  - 5.3 Cllr Barker reported that for the next financial year Council Tax has increased from 3.09% to 4.4% per household. She stated that low-income households will be able to claim rebates of up to £150.

## 6. COUNCILLORS' REPORTS

- 6.1 Cllr Bush reported that the heating in the flats in 5 to 15a Holloway Crescent is not working at this time. Residents tried calling the emergency telephone number to report this but there was no reply. The clerk will email Uttlesford to enquire if there are any changes on how Uttlesford Council tenants report problems in an emergency.
- 6.2 The Chairman reported that there were no knives handed in at the recent Knife Amnesty organised at Leaden Roding Fire Station recently.
- 6.3 After discussing with the Headmaster at Rodings School, the Chairman reported that during speed testing by police assisted by some of the school children on 19<sup>th</sup> January, a number of people were stopped with 5 drivers due to be prosecuted.
- 6.4 The Chairman confirmed that, as advertised, the Green Waste skip visited the school layby, Dunmow Road for the first time this year on 6<sup>th</sup> March (see below).
- 6.5 The chairman reported that after recent storm damage a tree blown over into Dunmow Road opposite the Granaries was made safe and then removed within 24 hours.


