Minutes of Little Cornard Annual Parish meeting held on 16th. May 2023 at 7pm at Little Cornard Village Hall

Present: Nick Hammond, Karen Gilbert, Cheryl Crane, Clive Johnson, Nigel Monk, Scott Savage, Mark Smith, Jill Thomas, SCC Cllr James Finch, BDC Cllr Lee Parker. There was also 7 members of public present

- 2. Welcome from the 2022-2023 Chairman (Nick Hammond) Nick Hammond welcomed everyone to the meeting

Most pupils receive a place at one of their preferred secondary schools. 98% of children were offered a place on National Offer Day at one of their three preferred schools and 93% were offered a place at their first preference school. Suffolk County Council received 8,083 applications from parents and carers indicating which secondary school they would prefer their child to transfer to in September 2023. This is approximately 300 more applications than received last year. Families who applied online can log on to the Admissions Portal from today to see the school their child has been offered. They will also receive an email to confirm this offer. – 99% of pupils receive a preferred primary school place on National Offer Day 99of children were offered a place on National Offer Day at one of their three preferred primary schools and 96% were offered a place at their first preference school. Suffolk County Council received 7,056 applications from parents and carers indicating which primary school they would prefer their child to join in September 2023. Families who applied online can log on to the Admissions Portal from today to see the school their child has been offered. They received an email to confirm this offer. Letters will be sent to parents who made a paper application – Help design a new Virtual Reality app for people living with dementia Suffolk County Council is looking for people to help develop a new Virtual Reality (VR) app for people living with dementia in Suffolk. The county council is inviting people living with dementia, their family carers, as well as health and social care professionals, who live or are based in Suffolk, to join a user group to help co-create the bespoke platform. The group will be called 'Synergy' and members will have input into all aspects of the look, design, and structure of the new VR app.

Over the last 10 years clinical research has demonstrated that not only do people with dementia tolerate virtual reality, but they can actually derive a wide variety of benefits from it, including improvements in wellbeing, cognition and communication. The app is being produced in partnership with Spark Emerging Technologies Ltd, who were awarded a contract by Suffolk County Council in December last year. To learn more about the user group and to apply visit suffolk.gov.uk/care-and-support-for-adults/virtual-reality-project ¬ Suffolk to mark Dementia Action Week with event at Trinity Park, Ipswich. This is a drop-in event for people with dementia, their families, and their carers, to be held next month at Trinity Park in Ipswich on Tuesday 16 May from 10 am, Representatives from more than 34 care organisations across Suffolk will host stalls at the event, which will showcase the wide range of information, advice, and support available to people living with dementia and their carers, to help them to get the right support from the right providers, at the right time. Running alongside the marketplace will be keynote sessions on a range of topics including how to live well with dementia from those with lived experience, memory assessment and the importance of a timely diagnosis. There will also be the opportunity for people with the condition and their carers to hear about the development of a countywide dementia strategy for Suffolk, and provide feedback on their experiences, needs and priorities for support. The event, which is being facilitated by the Suffolk Dementia Action Partnership and Care Development East, will be held on Tuesday 16 May from 10 am, at Trinity Park, Ipswich.

Suffolk County Council secures £2.65m funding from the government for the county's children's homes. The fund was set up by Department for Education (DFE) to enable local authorities to provide more placements within council run children's homes, as many councils have to commission residential provision which is costly. £1.9m of funding will go towards repurposing two children's homes. One children's home will be reconfigured into two separate wings to accommodate complex young people, this will provide 2

additional placements. The other children's home is to be developed into a provision for young people preparing to exit the care system. A wholly separate independence/training flat with its own external entrance will be created. This will be additional capacity at the home. The remaining £0.7m funding will be used, in addition to the £2m already approved by cabinet in November, towards the development of a new residential home for children and young people with disabilities at the Felixstowe Ferry Centre building in Felixstowe. The home will include three residential care places and two shared care beds. Shared care is when a young person spends a portion of time living with parents or carers and the rest at the home. ¬ Suffolk County Council's innovative digital care service, Cassius, clocks £10m savings. Cassius, Suffolk County Council's multi-award winning digital care programme, has released figures for its first 18 months in action. Since its launch in July '21 Cassius has: • reached 3,000 people whose lives have been changed with the installation of over 4,000 devices; • saved residents of Suffolk a collective 67,825 days in care homes; • avoided 400 ambulance call outs during a time of relentless pressure on emergency response teams in the NHS; • prevented hospital admissions and amounting to a saving of 500 hospital days, freeing up beds for those most in need; • saved £8.8 million of social care funding and £480,000 for the local NHS; achieved a happiness rating of 98.45% among Cassius users. Cassius has also been recognised with a hat-trick of awards from leading health technology publications. Last month, Cassius was awarded 'Best Innovation Project of the Year' in the Health Tech Digital Awards 2023 and 'Best New Assistive Technology Solution of the Year' at the Assistive Technology Awards 2023. Meanwhile, Cassius+, which is being trialled in West Suffolk and introduces additional health monitoring and assessment tools, such as blood pressure monitors, oximeters, scales, and thermometers alongside the established care technology offered by Cassius, has won 'Best Innovation Project of the Year'. As the UK's leading digital care technology service, Cassius delivers more safety, independence and confidence to Suffolk people and their families. A range of care technologies - video care phones, smart watches, monitoring sensors and falls wearables - support users to live their normal lives around their home and makes it simpler for loved ones to check in with them. The devices also give care professionals valuable insights into people's habits and vulnerabilities, helping build more personalised, empowering and less intrusive care packages that also reduce costly interventions and deteriorations in wellbeing. Crucially, Cassius relieves worry and increases wellbeing at a time that can be fraught with anxieties for more vulnerable people and their families. Increased face-to-face connectivity via the video smartphones, and peace-of-mind delivered by wearable devices and sensors that enable carers and families to check their loved one is up and about, bring huge benefits to people's lived experiences. The user happiness rating (98.45%) sits alongside endless user and family testimonies to show how Cassius really can be life enhancing.

Council has now installed 100 rural EV charging points, with more on the way Suffolk County Council's Plug In Suffolk project has now installed 100 electric vehicle (EV) charging points across the county, with the latest fitted at Risby Village Hall, near Bury St Edmunds. The council launched Plug In Suffolk in 2018 and was the UK's first 'fully open' public EV fast charging network and has seen other local authorities around the country follow in its footsteps. Risby Village Hall now has four EV charging points installed at its site, three 7kW chargers and one 22kW charger. They do not require any registration, membership or apps drivers simply park, plug in and charge using contactless payment. With an increasing number of EV drivers across the county and the UK, the council's ambition is to make Suffolk a well-connected destination for visitors and residents. We're a rural county and the infrastructure of charging stations is still developing, so our aim is for Plug In Suffolk to plug the gaps. We are installing the chargers at rural destinations such as public car parks, sports clubs, libraries and community halls. Although the initial phase of Plug In Suffolk is now complete, EV owners can look forward to even more charging point infrastructure across Suffolk, thanks to Suffolk County Council. The council has received £1,362,000 of funding from the Department for Transport, as part of the Local EV Infrastructure (LEVI) pilot scheme. This will see a total investment of around £2.75m, thanks to additional contributions such as commercial funding. The scheme will see: • PV solar power and battery storage upgrades to approximately 10 existing sites • Installing community EV charging, PV solar power and battery storage at over 30 further sites in urban and rural areas Identifying key commercial sites for 7kW, rapid and ultra rapid chargers, which will benefit the local community - New exhibition opens at Sutton Hoo telling the story of royal Anglo-Saxon Rendlesham Rendlesham Revealed: The Heart of a Kingdom AD 400-800 is a new exhibition opened on Thursday 23 March 2023 at the National Trust's Sutton Hoo, in Suffolk. The exhibition takes visitors on a 400-year journey to reveal how the Anglo-Saxon royal settlement at Rendlesham grew and developed, and celebrates the many volunteers from the local community who uncovered the long-lost archaeological remains. This story is brought to life with over 150 archaeological finds from the settlement, ranging from

food remains to gold jewellery, many of which have never been on public display before. Suffolk County Council's Archaeological Service is curating the exhibition to celebrate "Rendlesham Revealed", a community archaeology project funded by The National Lottery Heritage Fund. — Youngsters get the clean air message Schoolchildren across Suffolk have been learning about the importance of clean air thanks to a special drama production. Year 5 pupils at 30 schools enjoyed a performance of Abbie Ayre and the Shed of Science in which they learned about improving air quality safely and sustainably. It was based around the story of Abbie, whose grandmother is Dr Rosemary Ayre, an incredible scientist with a shed full of experiments and adventures. Together with her friend Charlie and Gran's supercomputer 'Derek 5000' they investigate the causes of air pollution and what they can do to make their world a safer, cleaner and more sustainable place. The production by theatrical company Performances in Education taught pupils to identify the causes and health consequences of poor air quality and to address ways in which they can avoid contributing to it, such as using sustainable transport. Suffolk Council teamed up with Babergh & Mid Suffolk District Council, East Suffolk Council and West Suffolk Council to fund the performances.

Cllr L. Parker informed the meeting that

Planning

- Over 1200 new homes approved
- Only 1.4% of planning appeals overturned at appeal
- We have gone from 121% of Government test on housing in 2019 to 143% in 2022

Housing

- In the last four years 333 affordable homes were delivered of which 165 were new council homes.
 Of the new council homes, 99 were for affordable rent and 23 for social rent. We also sold and
 delivered 43 new homes for shared ownership and 54 existing council homes through the right to
 buy scheme, with this boost to the housing supply helping many residents to find a place to call
 home.
- We have a scheme under way in Corks Lane, Hadleigh, due for completion in 2024. The buildings are being sympathetically restored to deliver 57 new homes.

Customers

- Over 67,000 emails have been sent and received
- Over 400, 000 calls

Grants

- £350,662 in capital grants allocated to 37 projects
- 261 grants to voluntary, community and social enterprise groups
- 33 projects receive minor grants totalling £27,509
- £226,962 in Section 106 funds to support 18 projects

- £43.8M in grants given to 8500 businesses
- We showed how we can respond at pace to extraordinary challenges, while lockdown also accelerated our digital development.

• We also saw our local communities step up magnificently, and this showed what can be achieved when people are empowered. Our grants helped many local groups carry out important work.

Recycling

- Recycling increased 12% from our 'bring' sites mainly glass, but also textiles.
- Green waste subscribers increased 17% to 16,789.
- Since 2021, we have given out nearly 3,000 bags of compost to residents.
- Babergh and Mid Suffolk Councils became the first rural authorities in the UK to commission a full tree canopy survey in the districts.
- Babergh District Council also started trialling wildflower verges. Grass cutting in specific council-maintained areas is reduced to give existing wildflowers a chance to thrive. Crucially, the flowers provide food for bees and other wildlife. Initially, grass is left to grow to see which wildflowers already exist. The council then cuts and seeds the areas with flower mixes as needed.

9. Update from Nick Hammond on the Little Cornard Neighbourhood Plan Nick spoke about the policies for the NP the Mere, Access to countryside, upkeep of existing footpaths plus establishing a footpath between Bures and Little Cornard. Views Dark Skies, Conversion of Barns perhaps speed of work is an issue! Non designated heritage assets spoke to George Mackay, he has spoken to the landowner and his solicitor no problem clearing access and any of rubbish in the Pill box. Happy if growth outside is removed and a plaque put up.

10. Update from Mark Irwin on Little Cornard's Quiet Lanes

The project to implement 'Quiet lanes' across Little Cornard was concluded in 2022 with 8 lanes in total being designated as 'Quiet Lanes'. Signage was erected in June 2022 for the following lanes:

Spout Lane - Wyatts Lane - Upper Road - Chapel Lane - Keddington Hill

Due to a shared boundary the following lanes were included as part of the Great Cornard Parish initiative and signage was erected for the following two lanes in October 2022:

Blackhouse Lane - Prospect Hill.

The project was heavily subsidised by Suffolk County Council and Little Cornard was asked to make a voluntary contribution of £250 towards costs which has since been paid.

Since Suffolk launched the initiative for 'Quiet lanes' in 2020, nearly 200 parish councils have engaged in the project and there are now more than 350 lanes designated in Suffolk, covering 400km or (248 miles) of country roads.

Little Cornard is now linked to Bures and Assington Parishes who both have designated 'Quiet lanes'.

Local residents welcomed and supported the initiative and feedback to-date has been positive. Consideration has been given to seeking to reduce the national speed limit on the lanes to 20mph but following the implementation of this by Assington Parish Council on the 'Street' it is believed that approval for this from County would not be easily forthcoming and costs would be prohibitive. There are no plans to proceed with this aspect of traffic speed control at this time. The project is closed.

11. Update from Ruth Adams on the Speed Watch

In Ruth's absence Nick Hammond informed the meeting that The Community Speed Watch team continue to carry out regular speed checks on the B1508, either at Henny View layby or at Willowmere Caravan Park. Sadly, the number of drivers exceeding 35mph is still very high

Janice Sampson does a sterling job in organising the surveys and reporting the data to the Police. She deserves our thanks.

We are pleased to have a new team member, Steve, who has recently moved into Little Cornard and has previous experience of CSW in Essex. We can now work with two teams and try to carry out two surveys a week, with an additional Saturday survey when we can. Of course, we would be grateful to have new members to spread the load.

Interesting to note that Letter 2 has been sent to ten drivers, which means they have been caught twice.

Janice has emailed Highways about the missing 30 mph sign on the 81508, reported on the Highways Reporting Tool on 29 March with works ordered on 7 April. The sign is still missing and the website states that the works should be completed within 20 working days. We await the installation of the new 30 mph sign within the very near future as the 20 working days have now expired. We can but try!

- 12. Update from Nick Hammond on the Bramford to Twinstead electricity network reinforcement project
- National Grid has just submitted the application for a Development Consent Order, Planning Permission.
- This is the first stage a of a six stage process which will take around 15 to 18 months to complete assuming the Government are happy to proceed.

The fence which is protecting the pond has been reported to Highways and is in a terrible state. The Parish Council should raise this issue again with Highways.

029/2024 County Councillors report - Total of 5 minutes is allowed £4.4 million to be spent for 60 additional staff to strengthen SEND reform.

Suffolk County Council's Cabinet has confirmed that 60 new members of staff will be recruited to drive forward important reform to the way special educational needs and disability (SEND) services are delivered in Suffolk. This includes an increase in permanent SEND staff of nearly 15%. These new posts will support the improvement of the quality and timeliness of assessments, plans, reviews, and communications with families. To support this improvement programme, an additional £4.4million was signed off during the budget discussions at Full Council on February 15. Of this, £3.4million will provide 46 new full-time posts – a increase of 15% in current staffing levels. An additional £1million will be spent in 2024/25 to fund 14 temporary posts.

Public consultation on Suffolk County Council's proposed devolution deal starts on 18th March 2024. A 10-week public consultation on our proposed devolution deal with the Government will start on 18th March and run through until 26th May. The consultation will be in two main parts – an open survey, hosted by Suffolk County Council, that any residents can complete and a sample survey of 1000 Suffolk residents conducted independently by Ipsos Mori. The consultation will be available through our website www.suffolk.gov.uk/devolution and social media. There will also be media coverage highlighting the consultation.

Dragon Patcher lands in Suffolk to bolster response to rural potholes. Suffolk Highways has welcomed the new pothole-repairing machine to help fix the growing number of potholes experienced nationally during the winter season, with a trial set to initially target defects in rural Suffolk. The Dragon Patcher is a machine that releases compressed air which cleans the surface of the road, before heating the surface to a temperature that enables repair material to bond effectively with the road surface, allowing the pothole to be repaired with an aggregate and hot bitumen material. Compared with the traditional approach of repairing potholes, the Dragon Patcher can work five times faster. This trial is in addition to the potholes being repaired around the clock as part of our routine repair programme, during the past two months Suffolk Highways has repaired 2,851 potholes across Suffolk. Fuelled by the biodiesel, HVO (hydrotreated vegetable oil), the patcher reduces raw material use and creates zero waste and has shown to provide significant carbon savings when compared to traditional patching techniques. Once the trial ends in Suffolk, a decision will be taken on whether to roll out the technology across the county.

Have your say on Suffolk's local transport plan. Residents are invited to share their views on how they travel to help inform Suffolk's Local Transport Plan. The plan sets out a long-term vision for transport in Suffolk and covers key themes such as decarbonisation of transport, strengthening the local economy, promoting health, wellbeing and social inclusion, and creating better-connected places that encourage a range of transport choices. Suffolk County Council is asking for feedback on the key themes proposed for

the fourth version of the plan, which will cover the period until 2040 and respond to long-term transport opportunities and challenges facing Suffolk and the UK as a whole. A link to the survey can be found at https://www.suffolk.gov.uk/ltp4. The consultation will run for eight weeks until 8 April 2024. Feedback from the consultation will be collated and inform the production of the draft local transport plan. The full draft document will then be subject to further consultation later in the year.

Suffolk County Council to review weed control for roads and pavements. In February 2022, the council agreed to stop using glyphosate in its routine weed treatment programmes, to find more natural alternatives to help protect the local environment. However, the alternative products proved unable to meet requirements, which was further exacerbated by exceptional growing conditions. Multiple applications were sometimes needed which could introduce other negative environmental impacts. Teams will continue to monitor and research the different approaches being used to remove weeds on our roads and pavements. However where needed, glyphosate would be used responsibly as it is one of the most cost-effective and long-lasting solutions.

Final Position Statement - Bramford to Twinstead (EN020002) - Deadline 9. Notwithstanding that Suffolk County Council (SCC) have always accepted the principle of the project, and has been able to support important aspects of it, including undergrounding in the Stour Valley and the removal of redundant 132kV transmission lines. SCC is so concerned about the shortcomings in the Applicant's proposals for the implementation and control of the construction of the project, that it must advise the Examining Authority and the Secretary of State that it formally OBJECTS to the making of a Development Consent Order (DCO) in the terms put forward by the Applicant in the draft DCO and supported by the current suite of control documents. The Council considers that the following management plans require substantial revision, due to insufficient detail, these issues are exacerbated by the lack of a commitment to a two-stage, (outline and final) process, in accordance with the comments submitted to the examination For more information refer to this link; -

The Police will continue to ask with a hope to ID the children so that they can bring about a resolution - This crime has been filed pending an ID. The police told me that there had been a few thefts from vehicles locally and a couple of burglaries in Sudbury and the Essex borders.

One of the main priorities for the police in the rural community is developing links to help tackle criminality - such as having a key network of individuals they can go to, to disseminate quick time crime information. I now have good relationship with our local officers and they will respond to incidents. We are getting regular patrols around the village and the police will attend the next Parish Council meeting in May. (Subject to operational calls)

I am still awaiting to hear from Suffolk Neighbourhood Watch and Suffolk highways. about the sites for our new signs. We will have to apply direct to BT instead of Suffolk highways to use their telegraph poles and only on the ones that have no wires running down them.

The NHW is set up to bring the community together and enable individuals and the community to be connected, active, minimise crime and make everyone feel safer.




