

# Little Totham Parish Council

## Minutes of Meeting, Tuesday 3<sup>rd</sup> June 2025

The Parish Council met on Tuesday 3<sup>rd</sup> June in the Evangelical Hall, at 7.30pm

**25.75 Apologies for Absence:** Apologies were received from Councillors Gritton and King.

**25.76 To invite Councillors to declare an interest in matters on the Agenda**

**25.77 Minutes 06/05/25**

**RESOLVED** that the Minutes of the Parish Council meeting held on 6<sup>th</sup> May 2025 be approved and confirmed.

**25.78 Review of councillor roles**

Councillor Hare asked for someone else to take over emptying the bin on the play area. Councillor Venton offered to help with this and it was agreed to review the need for this bin at the next meeting.

Clerk will update the list of roles on the website to include Councillor King as common land representative and Councillor Birkin has kindly agreed to take on writing the newsletter update each month.

**25.79 Planning enforcement**

Tolleshunt Knights Parish Council did not receive a request to the latest FOI request so wrote to the new Chief Executive at MDC. Their email was passed to Matt Winslow, Head of Planning who has offered to go through the enforcement cases with each parish.

**25.80 Common land**

It has been agreed with Mr Mabbitt that each party will pay 50% of the fees to Dyer and Crowe. Payment will be made at the end of the transfer process. Mr Mabbitt has confirmed that he does not want to keep the Lord of the Manor title. The common has not been cut this year and brambles are starting to encroach. Parish Council might be able to access grants for management when transfer has completed and will look at setting up a common committee with representation from the commoners and wildlife organisations.

**25.81 a) Planning applications**

No new planning applications.

**b) Planning decisions**

25/00218/PADOT Prior approval for change of use of buildings to flexible commercial use Little Renters Farm, Beckingham Street – approved

23/00366/FUL Appeal for retrospective application for change of use of land to domestic, stationing of mobile home and creation of a new access Willowbrook Farm, The Street – appeal dismissed.

### **25.82 Outdoor gym equipment project**

Clerk to contact Sovereign Play to discuss the need for planning permission and Councillors Hughes to speak with Matt Winslow to confirm the process.

### **25.83 Damaged village tommy**

It was discussed and agreed not to replace the damaged village tommy. Councillor Birkin will include a request in the newsletter to locate the other mobile tommy.

### **25.84 Connexin pole installation**

Chairman Lawrence has been in contact with Amber Dearlove at Connexin but communication has been frustrating and contradictory. He and Councillor Birkin attended a meeting organised by Wickham Bishops Parish Council with Connexin and Essex and Suffolk Water and they reported back from that meeting. Connexin will install on existing poles where they can, like telegraph poles but not electricity ones. The devices will monitor water meters to start with but could be used for other digital metering in the future. The poles need to be 2 metres below ground and are 10 metres tall so churches and private homes could be possible locations. A plan of proposed poles for CM9 area will be provided to the parish council.

A resident explained the problems she is having contacting Connexin or ES Water regarding a proposed pole near her home in Park Wood Lane. Clerk will email contact names and details to the resident.

### **25.85 Tru Cam report**

There were 4 captures for speeding during April. The clerk has compiled a list of former community speedwatch volunteers to be checked by Chairman Lawrence. These people will then be contacted to see if they are still available to relaunch the scheme.
