The Parish Council met on Tuesday 11th February in the Evangelical Hall, at 7.30pm

25.14 Apologies for Absence: Apologies were received from Councillor Hughes.

25.15 To invite Councillors to declare an interest in matters on the Agenda

Councillor King has an ongoing interest in the common land.

25.16 Minutes 07/01/25

RESOLVED that the Minutes of the Parish Council meeting held on 7th January 2025 be approved and confirmed.

25.17 Update for parish newsletter

Councillor King had already written a paragraph and sent to the clerk.

RESOLVED Clerk to add co-option of Cllr Birkin to the paragraph and submit to the newsletter editor.

25.18 Co-option of new parish councillor

Chairman Lawrence proposed and Councillor Venton seconded that Anita Birkin be co-opted as a parish councillor, and all agreed. Councillor Birkin signed the declaration of acceptance of office form in the presence of the clerk and the clerk countersigned.

RESOLVED Clerk to send link to register of interests form to Councillor Birkin.

25.19 Planning enforcement

The clerk had circulated MDC's response to the request for planning enforcement information to councillors and the clerk to Tolleshunt Major and Tolleshunt Knights Parish Councils.

RESOLVED Clerk to ask for feedback to the response from the other parish councils and discuss at March meeting when Councillor Hughes is present.

25.20 Common land

Councillor King left the room while this item was discussed.

Chairman Lawrence reported that he had been back in contact with Mr Mabbitt about transferring ownership of the common land. Dyer and Crowe Solicitors have given an indicative cost of £1,000 +VAT for each party to carry out the legal work and are prepared to represent both the parish council and Mr Mabbitt because there is no financial gain for either side. Mr Mabbitt has confirmed that he will cover his own legal fees. It was proposed by Councillor Hare that the land transfer is progressed and the parish council takes on ownership of the common land, seconded by Councillor Venton and all agreed.

RESOLVED Chairman Lawrence to report the decision to Mr Mabbitt and the clerk to obtain two other quotes for the legal work.

Councillor King re-joined the meeting and Chairman Lawrence updated him.

25.21 a) Planning applications

25.22 Outdoor gym equipment project

The clerk reported that she has been in contact with the Asset Manager at MDC who has confirmed that they could grant Landlords Consent for the installation of gym equipment in Sawyers Field and set up a document to legalise the agreement between MDC and the parish council. Other grant sources need to be explored now. Sovereign Play will attend on 17th March to assess the site and provide a free quote for the equipment and installation which can then be used in any funding applications, but other comparative quotes will also need to be obtained.

RESOLVED Clerk, Chairman Lawrence and Councillor Venton to meet Sovereign Play on 17th March.
