25.31 Update for parish newsletter

25.32 Switchover to digital phones in Essex

Councillors discussed the potential impact of the switchover particularly for elderly and vulnerable residents and what the parish council can do to raise awareness. Councillor Hare reported that her experience with the switchover has not been positive.

RESOLVED Clerk to find out timescale and if publicity material is available from ECC.

25.33 Planning enforcement

The clerk had received and circulated MDC's response to the FOI for planning enforcement information for Jan-Feb 2025 which had this time been requested by Tolleshunt Major Parish Council. The information being sent from MDC is not very detailed.
