72. Community Matters

- a. Maldon Road Playing Field. It was agreed that the clerk ask Craig Brewster to quote for the repairs that he had suggested following inspection.
- b. Allotments. After a discussion it was agreed that the weekend of 12th & 13th March would be when the allotments would be cleared. S Upton to make a start a couple of days before. Clerk to notify the allotment holders and to arrange a meeting on site to agree which areas needed clearing. c. Queens Jubilee. T Paoli-Burke reported the arrangements made so far for 3rd June. The marquee was organised and some caterers were already booked. It would be a free event. D Smith to give A Wallace the contact numbers for some other caterers who wouldn't charge for being on site. The event wouldn't only be for residents of Margaretting, but would be for neighbouring villages and families. S Upton proposed that the Parish Council support the event with a £2800 budget, this was seconded by H Blurton. It was agreed that any money left over would go back to the Parish Council.

Permission for work on the Willow Tree at Margaretting Tye would have to be applied for.
