- 73. Apologies for absence were received from Mr S Upton.
- 74. Declarations of Interest. There were no Declarations of Interest.
- 75. The minutes of the meeting held on Thursday 12th December 2024 were agreed and signed as a true and correct record.

76. Matters Arising.

- a. A Wallace reported that there was no feedback to report following his conversation to the Landlady at The Black Bull regarding the rubbish opposite.
- b. Bridleway over A12. Cllr Bonnett reported that this area fell within the Goat Hall Ward and had been reported.

77. Accounts.

The £5000 cheque for the P.W.L.B had been returned as only a bank transfer would be accepted within 48 hours of the Parish Council being notified of the interest rate.
