

A Meeting of Margaretting Parish Council took place in The Meeting Room at Margaretting Village Hall, Wantz Road on Thursday 10th July 2025 at 7.30 p.m.

19. Apologies for absence were received from D Smith.

20. Declarations of Interest. There were no Declarations of Interest.

21. Democratic Time.

A parishioner attended the meeting and outlined several problems that needed reporting. It was agreed that the clerk was to report the following; The ongoing problem with having the Dog Waste bins emptied regularly (Cllr Gillian Bonnett was also to contact the department) especially at Margaretting Tye. Infestation of Rats around the waste bins in the area opposite the garage affecting homes in Maldon Road. Clerk also to ask P Savill to mention in the Newsletter about feeding birds which also encourage rats, it was suggested that there might be a link to try and put people off feeding them. Clerk also to contact Planning Enforcement.

22. The minutes of the meeting held on 13th June 2025 were agreed and signed as a true and correct record.

23. Matters Arising.

a. Flag for War Memorial Flagpole. T Paoli-Burke to ask P Wood for the flags. A Wallace to take the flag down at the War Memorial after tonight's meeting.

b. Dog Waste Bin. Cllr Gillian Bonnett to contact department responsible and clerk to re-report. A Wallace to download a sign for the Maldon Road Notice Board to encourage usage of the Dog Waste Bin.
