15. Democratic Time

- a. Lamp Post opposite Penny's Lane Clerk to forward the reference number onto Marion Downie. b. Mr & Mrs Albon reported that the gates at the Parsonage crossing were still unlocked and they had been re-painted.
- c. Mr & Mrs Albon reported that the leak in the field was still ongoing due to a dispute between Landowner and Amenity Company.
- d. Residents from Wantfield Cottages attended the meeting and spoke about their concerns for the site opposite (Hawthorns) who had been given an Enforcement Order and had subsequently submitted a planning application, the Parish Council listened to their concerns. H Blurton outlined the history and planning applications for the site. The protected junction was still in hand. Also, parishioners are concerned that this will spread into back field. <u>Canford House, Wantz Road.</u> Parish Council comments; Taking this application and the one made on 16th May into consideration this is still an inappropriate development.

H Blurton reminded members of the parish council that homeowners can build a single storey rear extension up to six metres for terraced and semi-detached houses or eight metres for detached houses without planning permission as long as there are no objections from neighbours. This has been agreed by central government.

A Wallace reported that the planning forum, which was scheduled and he was to attend was cancelled.

There were no objections to Simon Upton being co-opted onto the Parish Council at the September meeting.
