a. Maldon Road Playing Field. Following the churning up of the playing field the clerk reported that she had sent a letter and photographs to the tree surgeon who carried out the work at the rear of 9 Bank End Cottages it was agreed that a copy of the letter is sent to Mr Jones's daughter. A Wallace
