42. Village Hall Matters

H Blurton reported that an order had been placed with Chelmsford Plumbing & Heating Ltd, who replaced the tanks previously to install the heating at a cost of £11,645.00. The village hall is applying

for a grant towards the cost. The estimated time for work is one and a half weeks, work will be carried out during the half term holidays.

43. Housing Needs Survey

Following an e mail from Laura Atkinson (RCCE) regarding a housing needs survey, the survey that was carried out before was discussed when it was found that there was no need for affordable housing. The only brown field site in Parsonage Lane was on the left-hand side behind the cottages. There was no guarantee to say that villagers would be prioritised to get a house, it was therefore agreed not to proceed.

<u>Eweland House.</u> 19/01271/FUL Proposed ancillary outbuilding

PC Comments; The PC objects to this application on the grounds that back in 2006 permission was granted for the erection of a double garage and it is felt that with this application it would be an over development of the site within the conservation area.

<u>Telephone Exchange</u> 19/01282/FUL Change of use from sui generis unused telephone exchange to Class B2 (restoration of classic cars) with ancillary parking and outdoor storage.

P C Comments; The PC object to this application on the grounds that:- The proposed change of use would increase the use of the vehicular access turning in and out of the site off and onto a section of dual carriageway where the speed limit it 70mph and the restoration of classic cars would be noisy and involve spraying the vehicles using cellulose paints which give out an unpleasant smell. Not what you want within the green belt or any rural area.

Whitewebbs Cottage 19/01351/FUL Change of Use from residential (C3) to a house of multiple occupation.

P C Comments; The PC object to this application on the grounds of inadequate vehicle parking. With eight separate occupants there could be at least eight vehicles needing spaces and since parking at the front of the property is limited it would only add to the problems that already exist with the parking of vehicles in Main Road and being so close to the crossroads.
