The January minutes were agreed to be a full and accurate record of the meeting.	LF
Regarding correspondence, correspondence was received from the bowls group about an issue with the floor. JF contacted the people who installed the floor and they advised that the issue should be monitored.	
An email was received from the Parish Clerk regarding the 50 th anniversary of the Battle of Britain, which is in September.	
LF took the meeting through the January accounts. There was a deficit for the month of £39.99. The large cleaning figure was due to paying for two months of cleaning at the same time, and this was also the month in which the gas and electricity bill fell. The miscellaneous expenses were the purchase of a gift for K Dean on his resignation from the committee.	LF

PW has a quote for putting fencing around the heat pump. It was decided to go ahead with this, due to the risk of damage to the heat pump from the general public. The lock on the downstairs door needs replacing. JF will ask Craig. The old downstairs toilets need removing and capping off so the room can be converted to storage. GH may be able to source a sink to replace the current sink in that area with one that is more useful.	JF, PW, GH
