I'm writing to you in connection with a small property which I understand is owned on a long lease by the Arch Company Properties Limited in Mount Bures, Essex, CO8 5DF.

This property is at the entrance to the village of Mount Bures in a prominent position when viewed from either the road or the railway. It is currently in a derelict state with the garden fenced off and asbestos piled up amongst the weeds growing high in the garden.

I am writing to you to ask you either consider measures to put the cottage and garden into a good order or to take alternative action, such as selling the lease, to ensure the issues with the cottage are resolved. The Parish Council, for whom this is a significant concern, have assured me they would take steps to encourage suitable buyers.

I would be most grateful if you could look at this and see what can be done to address this issue for the benefit of the local community
