 319/2021 MINUTES OF PREVIOUS MEETINGS: To receive and agree the minutes of Noak Bridge Parish Council held on Tuesday 23rd February 2020, proposed by Cllr Cottrell, seconded by Cllr Bunting that the minutes are a true and accurate record of the meeting - Agreed

324/2021 COMMUNITY PROJECTS UPDATE:

The chairman requested to change the order of business, for item 324/2021 to be brought forward to allow Rob Baker, Basildon Council to give an update on the Durban Lane Pond **Durban Lane Pond**

Rob Baker, manager of Parks & Countryside, Basildon Council was in attendance to report on the works at Durban Lane pond. After years of minimal works to the pond it was agreed by the Parish Council to set up a local meeting at the pond with residents and relevant parties to discuss what could be done to stop the pond from drying up. Following a very positive meeting where Rob outlined the phased works necessary to restore the pond, the Parish Council agreed to part fund phase 1 works to clear the pond to enable a long term prognosis to be identified for the phase 2 works. Basildon Council undertook an initial assessment for the phase 1 works and once complete an independent assessment was carried out to establish the extensive works needed by a specialist contractor. The Parish Council agreed to part fund the phase 2 works. Basildon Council undertook all necessary procedures prior to the works taking place. The works were never going to be easy, with the pond situated in a residential area with limited space and the need to use heavy machinery. Residents complained and called the Environment Agency who visited the site gave reassurance regarding the fish and wildlife on the site. 40 tonnes of silt was removed and dispersed of in holding bays around the pond which was an extremely difficult and messy task. Moving forward, in September once the soil and silt dries out more silt and the remaining reeds will be removed. Once this has been done plans are in place for future planting and homemaking for insects and habitat. In the long term the pond will not dry out or be overrun by reeds. The duck house will be restored as will the biodiversity, the wildlife will return and it will be a much better pond to be enjoyed by all

The Council are working on a Litter Pick plan which is proving difficult due to the risks involved and the safety of volunteers

Street Library Project

Two Little Libraries have been ordered, one for adult books and one for children. Once delivered they will need painting before installation. The chairman to ask the school if the children would like to help decorate the children's Library. Permission to install to be obtained by Basildon Council

320/2021 NEIGHBOURHOOD PLAN UPDATE:

The chairman proposed Bluestone Planning as the new consultants for the Neighbourhood Plan, seconded Cllr Cottrell - **Agreed**

Going forward the Neighbourhood Plan next steps: Following the hiatus over the last 12 months, the Noak Bridge Neighbourhood Plan Steering Group have been busy planning the next stages of the Neighbourhood Plan.

We have recently appointed new consultants Bluestone Planning to assist with the next steps in the process which will broadly follow the provisional timetable below:

Undertake gap analysis to determine what evidence is required to support the five key 'themes' identified following the September 2019 consultation: Transport & Roads;

Education, Health & Other Local Services; Design & Conservation; Environment & Green Space; and Housing – to be undertaken March 2021

Prepare Design Code for Policy H10 site (and other potential developments coming forward during the life of the Plan) – to be undertaken April to June 2021

Undertake additional evidence gathering to support policies – to be undertaken Spring to Summer 2021

Commence drafting the policies and supporting text for the first consultation draft of the Neighbourhood Plan – to be undertaken Spring to Summer 2021

Carry out first formal consultation on draft Neighbourhood Plan and Design Code (this will involve engagement with a wide range of stakeholders and the local community) – to be undertaken Autumn 2021

Review feedback from first consultation exercise, further work on draft Neighbourhood Plan and preparation of 'submission' version of Plan with a view to submitting it for examination by Spring / Summer 2022

We need volunteers to assist with evidence gathering, grant funding applications, writing text to go into the Neighbourhood Plan and other administrative tasks. Creation of an 18 hole adventure golf course

*The Parish Council have no objection to the application, however object to yet another activity in this vicinity that will encourage even more traffic onto the busy Barleylands Road and Wash Road that already has a huge impact on Noak Bridge residents. At weekends the roads are so busy residents have to queue to exit or enter Noak Bridge. The farm, despite growing many activities on the land over time that attracts numerous attendance has never contributed to a pathway or other infrastructure improvements along Barleylands Road on approach from Noak Bridge which has no pathway. It is unsustainable that Noak Bridge residents who wish to attend the activities have to drive to the events because it is unsafe to walk. Highways need to take an official approach to this growing concern and consider to jointly fund a pathway or at the very least come up with a sustainable transport plan to make it safe for residents to walk along Barleylands Road which is after all a country road where local residents fail to benefit. We would like this to be considered as a condition to the planning application

329/2021 BOROUGH/COUNTY COUNCILLORS' REPORT:

Clir Allen reported on the May elections

The Towers Blocks in the Town Centre that had received vast disapproval The expense of the proposed Youth Zone needing ongoing funding from the Council A planning application for an Incinerator in Pitsea

Cllr Ball reported on a task force set up to review the safety of women

A review on the night lighting has not proven crime is on the rise as attacks are just as likely to happen during daylight

The lowest infection rates had been reported since the beginning of Covid with no intense rise since the children had returned to school

Lap-Tops have been distributed to many children over Essex and free school meals would continue during the school holidays

The Locality Fund was continuing for another year with £10k for each Cllr to award funding for local projects. Residents of the parish were urged to apply

Pothole repairs were being carried out and working through a list reported by both Cllrs' E-Scooters are being trialled in specific areas over Basildon including a part of Noak Bridge. A driving licence and applicant details are required on registration, details of the scheme can be found on <u>e-scooters - Essex County Council (essexhighways.org)</u>

Clir Buckley reported Government funding had been devolved via Essex to Basildon proving an enormous help to residents, he also spoke of the task force to enhance public safety Another tranch of grants for businesses slipping through the cracks to even up criteria as we open up from Lockdown. Business grants given via Councils for the employment front <u>Essex Opportunities Portal</u> Kickstart scheme for young people to provide jobs and training Essex economy business support grants for youth development over 20 schemes from Government above average to Local Authorities in Essex

Roll out of vaccination, set out what can/cannot do by Dept of Public Health. Must continue to be compliant during better weather to stop the increase of infection
