30/2023 BOROUGH/COUNTY COUNCILLORS REPORT:

Cllr Allen reported that Basildon Full Council had set the Council tax at 2.9% the maximum allowance to ensure the continuity of services. An annual charge to collect garden waste had been agreed and financial help from the Government towards energy bills and the cost of living

31/2023 TO NOTE CORRESPONDENCE RECEIVED:

The Council discussed a resident media post on the local discussion page, quote:

"Having seen where funds have gone, I would like an investigation into just how much of Parish and Borough funds have gone to Peter Thomas, a resident volunteer, and Councillor Sargent. There is a lot more evidence I have and happy to share privately as I know they follow my comments"

The Parish Council concluded the media post made allegations of financial misconduct against the Parish Council and others and advised the resident making the allegations who was present at the meeting, to give any evidence in their possession, against the parish council of financial crime or otherwise to the police and ask for an investigation to be carried out. The Parish Council finances are reported and agreed at each meeting by the Council as a whole. No one member of

the Council can make a decision, the standing orders and financial regulations are strictly followed and updated annually. The Council fully comply with the Annual Audit (AGAR) requiring an internal and external audit, which are recorded in the minutes and published on the PC website. During the AGAR period the Council publish an annual Notice of Public Rights to allow any resident to view the parish accounts. The resident present was reminded of a request they made to the parish council to view the 2021/2022 accounts, but the request was not taken up by the resident. The Parish Council are no longer prepared for the resident to continue to make false allegations of financial misconduct against them or others when given opportunity to view the parish accounts was not kept. The resident's allegations against the parish council have been ongoing since May 2018 without being substantiated by the resident and will have to stop because of the unproven negative impact caused to the parish council
