31/2019 APOLOGIES FOR ABSENCE:

32/2019 DECLARATIONS OF INTEREST:

To receive any declarations of disclosable pecuniary interests, other pecuniary interests or non-pecuniary interests by Members relating to any agenda items. None received.

33/2019 MINUTES OF PREVIOUS MEETINGS:

To receive and agree the minutes of Noak Bridge Parish Council which was held on Tuesday 19th February 2019. Cllr J. Bunting proposed, seconded by Cllr M. Cottrell that the minutes are a true and accurate record of the meeting. **Agreed**

34/2019 RESIGNATION OF CLERK:

The resignation of the Clerk was noted.

Cllr Buckley commented on the high turn-over of clerks over the County which could mean a wider issue is at stake. He suggested it is brought to the attention of the EALC. The comments were noted.

40/2019 PLANNING APPLICATIONS:

Members to consider the following planning applications:

19/00196/FULL Location: Watch House Farm, Wash Road

Exterior alterations and conversion of former agricultural building to habitable annexe in connection with Watch House Farm

Comments:

The Parish Council object to the planning application for the following reasons:

The building is within the green belt with no very special circumstances

The building is not in keeping with the area

The size of the building is a major conversion far from the habitable annexe as described in the planning application.

19/00263/FULL Location: 49 New Waverley Road, Noak Bridge Replace existing timber windows and rear doors with UPVC

Comments

The Parish Council support this application only if the conservation management plan has been followed

That the windows and doors are replaced on a like for like basis and in keeping with the conservation status.

19/00319/FULL Location: 27 Bridgecote Lane, Noak Bridge
Replace existing wooden sash windows and cladding with UPVC sash windows and cladding (retrospective)

Comments:

The windows and cladding were replaced in 2010 and from the lack of information online it is difficult to determine if they have been replaced on a like for like basis as there are no pictures to be able to compare

The Parish Council can only support if the replacements are in accordance with the conservation status requirements.

PLANNING APPLICATION DECIDED:

Members to note the following planning application decided:

19/00105/TPOBAS Location: 27 Bridge Street, Noak Bridge

T4 of TPO/08/81 – Crown reduce back to previous pruning points and crown thin by 15% to epicormics growth only. **Application permitted**

41/2019 LOCAL COUNCILS LIAISON GROUP:

Cllr Cottrell reported Basildon Local Plan had been submitted to Government and may be completed by early next year if found sound. Inspector appointed. Basildon Council had new head of planning service with robust attitude to enforcement action. Consultation on waste over Essex was taking place. Consultation on proposal for parts of Wickford to become a Parish/Town Council.

42/2019 BOROUGH/COUNTY COUNCILLORS' REPORT:

Cllr Buckley reported on residents' request for a designated roundabout in the Coppice Lane shop area had been approved by the Local Highways Panel. This was met with disapproval by residents at the meeting stating access would be difficult. Following a discussion, the Parish Council asked Cllr Buckley if he could retract the plan which he made clear that pre plan cost had already been met. ECC are rolling out a programme to replace street lamps with LED over the County. Single bulbs needing replacement in the interim will have to wait until the programme reaches that area unless it is considered dangerous. Cllr Ball reported on the 'No right turn" scheme at Junction Noak Hill Road/ Dunton Road currently under consultation. The results were reported to the Highways Panel that the scheme had been effective. Residents confirmed that the scheme had caused far more traffic onto the Steepleview area ending at the Police garage where it was causing far more congestion on the Pipps Hill roundabout and Wash Road. Uturns still being witnessed at the scheme regardless of the bollards although more bollards were proposed for installation. Consultation on the bus routes had provided a 50/50 response Library consultation had exceeded 2100 comments, the closure of some libraries would mean existing libraries could still be used. No decisions had been made. ECC were carrying out an assessment of contractors Ringway Jacobs who held the Highway contract which had gone to a scrutiny review. Report available on the ECC website.
