

MINUTES OF NOAK BRIDGE ANNUAL PARISH COUNCIL MEETING HELD AT NOAK BRIDGE VILLAGE HALL, COPPICE LANE, BASILDON, ESSEX, SS15 4JS ON TUESDAY 16th May 2017 @ 7.30PM

17/205 ELECTION OF CHAIRMAN:

Cllr. Bunting proposed Cllr. Terri Sargent as Chairman, seconded Cllr. Jarvis.

As the Councils wish, the Chairman of the Council signed the Declaration of Acceptance of Office, and Cllr. Bunting be permitted to sign as witness in the absence of a Clerk -

17/207 DECLARATIONS OF INTEREST:

17/208 APPOINT VICE CHAIRMAN

It was agreed Cllr. Jane Bunting be appointed as Vice Chairman, proposed Cllr. Sargent seconded Cllr Jarvis - **Agreed**

17/209 MINUTES OF THE PREVIOUS MEETING:

The minutes of the Parish Council Tuesday 18th April 2017 were received and approved, proposed Cllr. Bunting, seconded Cllr Jarvis. The chairman clarified that 2017 minutes and agenda numbers to date had been prefaced with 16 by mistake and had now been changed to 17 - **Agreed**

17/210 TUDOR STYLE BUS SHELTER - RECLAIM GRANT:

The Chairman reported the previous Parish Council had not reclaimed the CIF grant from Essex County Council for the improvement works carried out on Tudor Style Bus Shelter in Bridge Street. The Parish Council has since made a claim to ECC and the sum of £3,500.00 has been awarded. Cllr Malcolm Buckley was asked to pass thanks from the Parish Council to ECC.

17/220 B/F - BOROUGH / COUNTY COUNCILLORS' REPORT:

The Chairman agreed for item 17/220 to be brought forward as Cllr's. Ball and Buckley had another meeting to attend.

Cllr. Buckley reported the he and Cllr. Ball had been elected to serve the Wickford/Crouch Division in the May 2017 Local ECC elections.

Cllr. Buckley reported, the roundabout on Coppice Lane by the shops was to be reviewed by the Basildon Highways Panel with the possibility of a viability study. Consultation could take place at the end of the financial year. This was the result of residents reporting dangerous driving around the roundabout and parking on school zig zag lines during restricted hours.

The new Highways cabinet member at ECC is now Cllr. Ian Grundy.

Cllr. Buckley informed the meeting that the ECC Community Investment Fund was now open for community projects.

Cllr. Ball reported he was the deputy Cabinet member for Education and offered help to the Parish Council on future schools projects. Resident complained of tree height in the Noak Bridge School grounds and asked Cllr. Ball to investigate.

A resident showed the Parish Council a letter in a local newspaper complaining about the proposed no right turn at the Wash Road / Dunton Road junction. Residents and Cllr's were in agreement with the letter that a roundabout at the junction was the best solution. Cllr. Buckley to raise with Highways, the Chairman to write to Cllr. Grundy.

17/211 COMMUNITY PROJECT - PETANQUE:

Cllr. Bunting informed the meeting the Petanque Court would be installed in the garden of the Village Hall as this was considered the most suitable site. The working party had met and agreed the layout of the court with provision for benches, new gates and fencing. Three contractors have been asked to provide quotations ready for the next meeting to allow installation for the summer. The Budget provision was £10,000.00. Proposed Cllr. Jarvis, seconded Cllr, Cottrell - **Agreed**

17/212 BANK DETAILS / FINANCE:
