55/2019 PLANNING APPLICATIONS:

19/00414/FULL Location: Abbeyfield Octagon House, 41 Bridge Street, Noak Bridge Single storey rear extension

The Parish Council support the planning application for a single storey rear extension. All material to be used on the extension are fully compliant with the conservation area status. The build itself is in keeping with the Octagon House It does not overlook or is overbearing on the residential amenity

19/00458/S211 Location: 6 Gate Lodge Square, Noak Bridge

Section 211 Notice. Oak Tree - Crown Reduction between 2m and 3m back to original pruning points. Noted

19/00460/FULL Location: Bensons Farm, Wash Road, Noak Bridge

Extend and convert redundant barn into offices (Class B1(a))

The Parish Council object to this planning application

It lies within the green belt and the size will interfere with the openness

The change of use from a barn to a 2 storey offices is inappropriate use of green belt land.

To convert a barn into offices in the green belt is not special circumstances

PLANNING APPLICATION DECIDED:

19/00347/S211 Location: 37 Durban Lane, Noak Bridge

Section 211 Notice (T1 Birch) fell to ground level. The tree is a poor specimen having received heavy pruning in the past, the tree is very close to the

neighbouring garage and conservatory. Application Closed.

19/00093/FULL Location: Daniels Farm, Wash Road Laindon SS15 4AZ

Demolition of side addition, new chimney stack, proposed single storey and two storey rear extensions and internal alterations (revised scheme) - **Refused**

56/2019 LOCAL COUNCIL TAX SUPPORT GRANT:

Cllr Sargent reported, the Council had been contacted by Billericay Town Council asking if NBPC would like to support a Town/Parish proposal for John Baron MP to write to Basildon Council asking them to consider reinstating the Local Council Tax Support Grant they had withdrawn in 2017. On considering the proposal, Cllr Jarvis proposed, seconded by Cllr Bunting to support the request - **Agreed**

Cllr Allen reported on the change of Administration at Basildon Council Basildon was now a market place for development Freedom House had finally been vacated

Cllr Ball reported at the May 2019 ECC AGM he had joined the cabinet as member for Economic Development, he was congratulated by the Council Pothole repairs continued and he and Cllr Buckley would be carrying out an assessment of Local Potholes in the division and prioritise those most urgent The review on road traffic in Dunton Road was complete and found no increase in traffic as a result of the 'no right turn'

A Highways Panel meeting on 10^{th} June is likely to accept the scheme permanently
