Councillors welcomed to the meeting and signed the acceptance of office. Clerk forwarded new Councillors a copy of the Good Councillor Guide and explained the declaration of interest process. Councillors confirmed that they had no declaration of interest on any items on the agenda.

## 15/048 'Tudor Style' Bus shelter in Bridge Street

Cost of insuring the 'tudor style' bus shelter will be £56.50 per annum, this will be pro rata for the remainder of this year. The works will be carried out in early November, once the date is known a newsletter will be circulated and a notice of the closure affixed to the shelter to inform residents. In addition to this the Clerk

will contact Essex County Council Infrastructure Development Manager to advise him of the closure.

Highways have stated that due the curve in Bridge Street it would not be possible to arrange a temporary stop while this works is carried out. The anticipated time scale to renovate the shelter is 3 working days.

Communication from Essex County Council received regarding the Installation of Real Time Information (RTI) boards at the shelters below:

- Bramble Tye existing shelter to be replaced with new metal shelter = Clerk to contact ECC to request that this shelter is replaced with a timber not metal shelter to mirror the opposite side of the road. RTI to be installed .
- Abbeyfields RTI to be installed within the existing shelter
- Lower Street: RTI will be installed in both shelters on either side of the road. Clerk to liaise with ECC regarding the renovation works being carried out by the Parish Council.
- South Wash Rd Metal shelter to be replaced with new metal shelter and RTI board to be installed in the shelter = Parish Councillors would prefer a wooden shelter at this stop, Clerk will request this although advises that in her opinion it is unlikely to be a wooden shelter due to the location and that its currently a metal shelter in situ.
