- 1. - 4. Where it is determined that the neighbourhood plan is unlikely to have significant environmental effects (and, accordingly, does not require an environmental assessment), a statement of reasons for the determination should be prepared. A copy of the statement should be submitted with the neighbourhood plan proposal and made available to the independent examiner.
- 5. Planning Practice Guidance confirms that an appropriate assessment, under the Conservation of Habitats and Species Regulations 2017 (as amended), identifies whether a plan or project is likely to have a significant effect on a habitats site, either alone or in combination with other plans or projects. This assessment must determine whether significant effects on that site can be ruled out on the basis of objective information.
- 6. If the conclusion is that the plan is likely to have a significant effect on a habitats site then an appropriate assessment of the implications of the plan for the site, in view of the site's conservation objectives, must be undertaken. If the plan is determined to require an appropriate assessment then it will normally also require a Strategic Environmental Assessment.
