The Parish Council *OBJECTS* to this application. Over the years an excessive amount of soil has been imported on to this site, raising and changing the land form. This area is already on high ground, and further raising of the land form by an additional 2m would cause an unacceptable level of change, which would be detrimental to the openness of the green belt and the character of undulating land form in this area.

- b) It was *NOTED* that on the weekly list dated 18th May 2018 was application EPF/0949/18, for Upper Clapton Rugby Club for a proposed new all-weather pitch to replace existing grass pitch and relocation of approved floodlights, alterations to approved function hall, alterations to approved car parking layout including provision of additional spaces. During the address from the representative of Upper Clapton Rugby Club who was present, it was stated that this was related to the enabling development as discussed earlier in the meeting, and it should have come to this Parish Council for comment at the same time as EPF/0917/18.
