ON BEHALF OF CLLR WRIGHT, THE CLERK HAS LIAISED WITH THE FARMING FAMILY CONCERNED AND INVITED A REPRESENTATIVE TO SPEAK AT THIS MEETING, COUNCILLORS WERE ADVISED THAT A SMALL PRE-PLANNING MEETING HAD BEEN HELD AND THE SUGGESTIONS WERE THAT THE CELEBRATIONS WOULD BE HELD IN A FIELD WITH A BARN FOR COVER IN CASE OF INCLEMENT WEATHER, THERE WOULD BE PLENTY OF PARKING AND PORTALOOS WOULD BE ARRANGED, IT WAS PROPOSED TO LIGHT THE BEACON, PROVIDE MUSIC AND A HOG ROAST FOR £5.00 A TICKET, THOSE ATTENDING WOULD NEED TO BRING THEIR OWN DRINKS AND CHAIRS, COUNCILLORS APPROVED OF THESE PROPOSALS WHICH WOULD ALSO BE PRESENTED TO THE VILLAGE HALL COMMITTEE.
