4. Public participation session

Several members of the Parish were present to discuss the need of dog waste bins in the village.

Alison Jeffs presented a short speech to the council for the necessity of dog waste bins in the village and handed over a petition signed by residents and visitors to Pleshey. Beverley Weatherley presented a short speech in favour of the need of the bins and raised several points to the benefit of the bins. She expressed the fact that dog faeces was getting worse in and around the village and that it was a health hazard to the public. The council decided to investigate the costings and locations of the bins and to put the matter on the agenda for discussion at the next meeting.

5. Report from ECC and CCC attending Councillors

Cllr Aldridge provided an update on current issues at the County Council. He advised the council on the successful waste collection service although he expressed the need for residents to continue to reduce waste going to landfill. He advised that High Easter residents had complained about potholes on the Bury Road and that he will contact the highways department.
