Covid vaccination supplies have dropped slightly due to minor changes in production however this will quickly return to normal levels and provide added capacity. EALC Lockdown Support Fund has been renewed for the next financial year with provision for £500k..

Pothole repairs - some temporary while permanent repair awaited.

The New Chelmsford Station will proceed and a £200m fund will be drawn down in support of this.

Budget - no increase in ECC but a 1.5% increase to the social care ring fenced fund. The £10,000 Locality fund will continue in 2021-2022.Local Highways Panel for the next 5 years budget increased to £700k per annum.

Chelmsford E-Scooters - All Orange livery from the hire company. Non-hirers are not allowed on the footpaths .

Army & Navy - last vestiges to be removed in the next few days.

Chelmsford North East Bypass - should be approved mid year 2021

Gritting around the Bus Stop in Back Lane , Pleshey to be investigated.

Cllr Mike Steel introduced himself as he is a Chelmsford City Councillor, Great Waltham Parish Councillor and Chairman of the Great Waltham Parish Council - he will be standing for election on the Essex County Council when Cllr ALdridge retires.
