2021/472 Report from Essex Councty Council - Cllr Mike Steel

In role for 1 month and on the Highways Committee, Health & Wellbeing board and the Local Highways Panel. The new leader of the Council is Kevin Bentley and the new Chairman is Eddie Johnson. Potential to escalate and influence Highways repairs if an immediate safety issue, and large footfall, no impact on low priority repairs. Use the Highways site to report issues. The tender has just been re-run – clarification on the number of "entitled" children. However, the tender does not include school children who purchase additional seats.

There is a danger/reality that school buses will disappear and be replaced by smaller cars. The main tender criteria is cost. Representation to the Highways Cabinet Member,:

Cost should not be the only criteria.Replacing buses with numerous cars for the entitled children has a negative environmental consequences as well as removing the positive social aspects of interaction between kids.Using cars rather than buses, will mean there are no spare seats to purchase, and all the paying customers will get transported by parent's cars with more of the same negative consequences. The Highways Cabinet member has taken this to the leader of the Council, whose main theme is the green agenda. I have a follow up meeting on 10<sup>th</sup> June.
