2021/622 Report(s) from External authorities

County Council budget 22/23 - Statement from Cllr Bentley, Leader of the Council: The proposals align to our agenda set out in Everyone's Essex – the plan for Levelling Up the County and includes investment in families, communities, the economy and environment. To be able to achieve our ambitious Everyone's Essex plan, and to deal with rising demand for key services and address costs pressures due to inflation and utility cost rises, we are proposing a council tax increase of 4.49%. This is made up of 2.99% rise, with 1% dedicated to Adult Social Care, plus the 1.5% for Adult Social Care that was deferred from last year.

This would mean that for an average Band D property household, the ECC element of council tax will increase by £60.21 next year, or £1.16 per week.

We have a stark choice – either we propose an increase, or we face unacceptable decisions about reducing services. Ultimately, we are not willing to compromise the level of service residents receive. We are committed to making sure vulnerable residents receive the care they need, that the roads we travel on remain safe, that we invest in communities continue to and that our environment becomes greener, cleaner and healthier.

We will be debating these proposals at the cabinet meeting on the 18th of January, and any recommendation will go to Full Council in February
