### 2022/809 Public participation session for anyone with an interest in the Parish

- 1 members of the public to raise three concerns.
- Concerns raised over the possibility of the refurbishment of the golden jubilee Play area creating an opportunity for ball games. The Parish Council confirmed that no ball game equipment was being installed as the Village Hall has all that's required.
- Noted that at last month's meeting the issue of water on the allotments was raised. The Parish Council confirmed there are no plans to put Water on the allotments as the cost is over £3,500 to install a stand pipe.
- Concerns about the lack of care by drivers that have parked cars on the footway in back lane.

Rule 244 of the Highway Code states that drivers "must not park partially or wholly on the pavement in London" and should not do so elsewhere unless signs permit it. Parking on the pavement can obstruct and seriously inconvenience pedestrians, people in wheelchairs or with visual impairments and people with prams or pushchairs.

The funding from the National Lottery application has been received. The works start on the 2<sup>nd of</sup> March.

### 2022/818 Mechanism for works to be undertaken at the Golden Jubilee Play Area An advertisement was placed in the Pleshey news and no volunteers have come forward to undertake the works.

### 2022/819 Risk Register.

Diversions on to inappropriate roads when utilities or road works are being undertaken to be added to the register.

2022/820 Trees around rooters hill bridge – ownership and potential removals.

The trees are owned by the Knight family, and it is expected that they will be removed at an appropriate time in the future.

### 2022/821 External authorities report.

Essex County Council have planned a 3.5% increase in the council tax (2% Adult social care) and 1.5% for other expenses. Expect the council to pursue savings which are still to be identified and its likely to effect services in the new Financial Year.

The highway rangers are being disband by the end of the financial year.

Member led pothole scheme – around 50 reports have been put in by Mike that covers 80 holes have been submitted. The potholes are patched not repaired.

Local roadworks and the subsequent traffic routing is causing concerns as it's on to narrow lanes.

Vicarage road routing of road works and issues raised by the Parish council was unable to be resolved. The 20mph LHP is In validation with the speed surveys to be run in the new financial year.

Speed Indicator device new scheme using lamp posts being a possible solution for the posts to hold the unit.

Essex County Council does not have a plan of protected lanes. The Chelmsford City Council planning department may have access. These may be on the local plan.

Traffic levels are up in Chelmsford city council, but parking is down concluding that work at home residents is undertaking small local journeys.

The recycling center new scheme is going live as a trial runs until the autumn.

2022/822 Coronation Event to coincide with the 6<sup>th of</sup> May.

An event is being coordinated within the village and centered around the public house. Sunday street party with a road closure.
