1.	The BELL FIELDS
Peter Maloney	Why has the current PC used the Bell Fields as an item of expense in their Precept, for the last two years, despite no money being spent on it? In 2016 an amount of £450 was allocated and £4000 further being allocated.
Keith Marshall	Why has the planning application for the pavilion on the Bell field been allowed to expire? Why has there been no explanation of this? There was a survey done 4 years ago where the majority voted for the building of the pavilion, why has this decision not been followed? Why has the Precept increased but the only visible evidence of work by the PC is the addition of a dog bin and the buying of a defibrillator?
Chas Spearman	There was no mention of the pavilion project being abandoned in the PC manifesto, has the PC misled the public to get elected only to ditch the project?
Ron Fallows	Can you tell us about when the information to answer these questions will be forthcoming?
Tom Chapman	The answers will be discussed in an open meeting, but not the next open meeting. The questions are being recorded in writing and the answers will

Paul Mayhew	There has been an increase in the Precept, but are not supplying any
	money to the village Hall or the Bell Fields, and now to the newsletter. Why not?
Dave Upton	Some of the PC refuses to acknowledge the survey already conducted by the previous council. I propose an official Parish Poll should be conducted on whether there should be a Community building supervised by the Electoral Services of Chelmsford City Council. The question that should be asked is "Should there be a multi-purpose Community building in the Upper Bell Fields, and paid for from the Parish Council reserves? Options: YES or NO"
PROPOSAL	PROSPOSED BY DAVE UPTON SECONDED BY KEITH MARSHALL This will be paid for by the PC and everyone on the electoral roll will be able to vote. A list of the people present who agreed with the proposal was taken, and the abstainers and those unable to vote noted. 17 residents of the Parish of Rettendon accepted the proposal There were 3 abstainers and 6 unable to vote, due to not living in the parish.
Dave Upton	I would like to give the reason for bringing this up. I would like to stop the arguing. I would also like to make sure the PC will agree to the poll, and not worry about who is on a trustee, just get on with it.
Ron Fallows	For the poll the ordinary rules of election counting must apply.
Gill Mayhew	Is the money earmarked for the pavilion still being held in reserve?
Tom Chapman	Roy wanted to describe his plans for the pavilion but I am concerned about the time, I asked Roy if he would be happy to do this at the end of the meeting if there is time. (Roy Hart agreed to this). Are there any more questions about the Bell Fields? No we will continue.
2	VENUES
Keith Marshall	The PC meetings have always been held in Rettendon Village Hall and were moved to Tuesdays for convenience. Why are they to be moved from the hall?
Paul Mayhew	Why is the venue for the PC meeting to be moved from the hall?
Peter Maloney	The Village Hall has been used for the PC all the time. Is it that now only Battlesbridge Church hall will be used? The PC is not supporting the Village Hall at all, and is now not paying for the insurance. This PC is now dead against the Hall and not supporting them, but the PC is still claiming the Precept for the hall. Because the PC no longer pays the insurance for the village hall they have put the rent up to the PC is this the real reason for moving to Battlesbridge does the PC have it in for the Hall and getting back at them by not supporting them.
Chas Spearman	Come clean on who is pulling the strings behind the PC.
Tom Chapman	From a personal point of view about the change of venue from a personal point of view not on behalf of the PC as I proposed it. 	maintenance. Could this be confirmed?
Tom Chapman	Any other questions?
Hazel Dale-Evans	There is a working party for which 2 councillors have volunteered, but they would like 2 people from the estate to join them.
Paul Mayhew	What would it involve?
Tina Sampsey	I live backing on the area. I would be willing to be part of the working party.
Janys Jefferies	What about the inspection of the field? There have been no inspections since the contractors started. There used to be inspectors come round to make sure the maintenance was done correctly and that the equipment was not damaged or needed repair. Who are the people who are inspecting and checking the equipment and the maintenance now? Are they qualified?
Chas Spearman	I have seen the contractors "inspecting" the equipment. They have a quick look and kick the equipment to make sure it does not move.
Scott Wilson	The maintenance of the playing area was bad before. My children played there and the grass was not cut properly and was not collected, leaving grass stains on clothing, and there was dog muck around. The play area in Woodham Ferrers is much better cut, and the weeds are removed. The maintenance needed improving. We should have the skills to look after our own backyard, manage our own assets as much as possible with anything extra. There will be extra money needed for extra cuts and the money is coming from the council.
Hazel Dale-Evans	Since your children play there are you willing to go on the working party?
Scott Wilson	Yes, I will go on the working party.
Chris Cheater	The Sonter's Down play area is not an asset of the Parish, it is owned by the CCC. The PC decided to maintain the area themselves on the basis it could be better maintained and at no extra cost. Why has the special expense charge by CCC Parks Department to the PC, previously £1,924 for the year, been replaced by a £4,000 provision in the budget and now an earmarked amount of £20,000 made? It seems to be in the first year of looking after the Sonter's Down area the playground has cost £24,000, instead of less than £2,000 when maintained by CCC. Residents and councillors were told it would not cost any more money and only a small amount of money per year be earmarked for replacement of the play equipment. This appears to be double taxation. Have we been misled about the actual costs to residents and councillors? The CCC are closing other play areas but have agreed Sonter's Down is OK. The money residents pay has now gone up because it is now under the PC. In the latest newsletter, Councillor Jones is incorrect about how the Precept works, also why has the PC now decided to ask for ideas on how to improve the play area, did they not have these plans before taking over the extra expense of running it?

Appendix: Extract from the Rettendon Review of 1968, page 16

An important difference between Parish and larger units of government is that the electors should know the Councillors as people. What better form of democracy could you have the certainty of being able to attend a meeting where you can tell your Councillor exactly what you think of him or her.

Parish councils are limited in the services which they provide and the amount of money they may raise. Parish Councils may provide a swimming pool, tennis courts, football pitches or 'bus shelters. They may also provide and maintain Parish Halls, public seats or public clocks, provide allotments and burial grounds, plant trees, repair footpaths and make grants for the upkeep of the Churchvard and War Memorials. But one of the most important functions of the Parish Council is to be watch-dog for the Parish, on the activity of the larger authorities and to see that the wises and opinions of the parish are made known.

A rural parish with its own Council is the only form of local government which can offer such privileges to its electorate.
