186-17/18 Apologies and Reasons for Absence

Apologies were received from Cllr Chapman.

187-17/18 Declarations of Interest on Items on the Agenda

There were no declarations of interest.

188-17/18 Public Forum – strictly 5 minutes only per speaker

A resident said he would like to thank the Parish Council for all they do, and in particular the ward councillors for their work.

A resident thanked Cllr Chapman for the manner in which the Parish Meeting was chaired. He said it was a pity other councillors could not attend, and he thanked Barbara Wright for taking the minutes. He asked Cllr Ride as a member of the Local Highways Panel if he would comment on highways issues. He referred to the issue of the village gateways and the involvement of Ringway Jacobs. He said the Council's Financial Regulations and Standing Orders meant that three quotes should have been obtained. He said the Parish Council was aware of volunteers who would do the same job and save the Council £18,000.

The Chairman said he had had a prior engagement for the night of the Parish Meeting and had sent his apologies. He said the gateways were not on the agenda for this meeting.

A resident referred to the draft budget and said he was concerned about the unallocated reserves. He asked for a copy of the Parish Meeting minutes as Cllr Chapman had gone ahead with arrangements for the Parish Poll. He asked why the public would be excluded when Items 203-17/18 and 204-17/18 were discussed.

The Chairman said as Items 203 and 204 concern legal advice given to the Parish Council it was appropriate to exclude the Press and public from the discussion.

He reminded residents that the Local Development Framework to take the City Council to 2035 was reaching an advanced stage and urged residents to attend the meeting on 18th January 2018 to see where new houses would be built.

Cllr Hart referred to the bus service through the parish and said no tenders had been received for service 1. Service 3 with extra stops would begin from mid-January 2018.

Cllr Hart referred to Item 177-17/18 and said he had asked the question about blocking off the entrance to the Bell Fields. He said the Chairman had denied knowledge of this. He said he had an email from Cllr M Fleming regarding blocking off this access.

The Chairman said there was concern about travellers gaining access and said there was no intention to block pedestrian access.

Cllr Hart said he would like it minuted that the Chairman was a liar.
