He said there was an injunction in force with regard to work on Hayes Country Park and that the case would come before a judge soon.

The Parish Council agreed to support this application.

20-17/18 To discuss Parish Council contributions to the Rettendon and Battlesbridge Newsletter including potential expansion of the newsletter to allow more content

The Chairman asked the Editor of the Rettendon and Battlesbridge newsletter to address the meeting.

The editor said other parish magazines have content from Parish Councils and ward councillors. She asked if it would be possible to have more from the Council regularly. She said it might be worth considering.

The Chairman asked if it was something the Council could consider.

Cllr Hart said if an extra page was added this could possibly include adverts but he felt the newsletter was acceptable as it stood.

Cllr Jones asked if a synopsis of the minutes could be included.

The Clerk said she would be happy to do this. She said it would be worth looking at options for expansion of the newsletter on a regular basis as

including more from the Parish Council would give the editor more difficulty in trying to fit everything in to the available space.

Cllr Jones asked if we could get quotes from other printers.

The editor of the newsletter said she would look into this.

He asked for confirmation of the date of the meeting of the charities' trustees at which this request had been agreed.

25-17/18 To agree to accept one of the three tenders submitted to the Parish Council for maintenance of the Sonters Down Play Area

The Chair said this Item would be moved down the agenda to allow Cllr Ride to take part in the discussion.

26-17/18 Finance

Cllr Cheater asked about his previous request for sweeping of the cycleway through the parish.

The Clerk said she had contacted various people about this but it had been difficult to find anyone who was responsible. She said if Cllr Cheater could clarify exactly where the sweeping was required she would continue to chase this issue.

Cllr Jones said she was looking into the possibility of a parking place on Buckhatch Lane and had contacted Paul van Damme at ECC.

28-17/18 Street Lighting

There were no issues.

29-17/18 Items from Councillors

Cllr Hart said there had been a spate of travellers in Rawreth. He said he had checked in Battlesbridge and the landowner would be putting a gate on the land on Hawk Hill.

The Chairman said the Council would now consider Item 25-16/17

Cllr Hart said he had already made his feelings clear on this issue. He said he did not agree with the Parish Council taking responsibility for the play area. He said none of the tenders should be accepted and that the previous arrangement with Chelmsford City Council should be resumed.

Cllr Ride said Skippers Ground Maintenance had provided the lowest quote which covered grass-cutting, weekly inspections of the play area and litter removal. He said the point of the Parish Council taking on the responsibility for the play area was to improve maintenance standards.

It was **agreed** to accept the tender from Skippers Ground Maintenance for the maintenance of the Sonters Down Play Area.
