128-18/19 Apologies and Reasons for Absence

a) To receive an update from the Working Group

The Clerk confirmed that the contractor has been asked to replace the broken bollard, and that she has chased again regarding the gates' mechanisms.

b) To agree to replace the signage at a cost to be specified

It was agreed that the signage would be replaced at a cost of £131.62, as circulated prior to the meeting. This would exclude the cost of installation.

Cllr Jones said that the contractor approached was the one used by Chelmsford City Council for their signs. She said the signs would clarify the Parish Council's responsibility for the Play Area and that there is specific information that is required.

140-18/19 Highways and Footpaths – to note Essex Highways Notices and receive reports from Councillors.

Cllr Jones said issues in Old Bell Lane had been reported to Essex County Council: reference numbers 2595526 and 1835356

She referred to the dog waste bin by the Wheatsheaf and said there were rules about the siting of these bins. She said all had now been sorted.

Cllr Hart asked for clarification about the specification for replacements of the gateways. The Clerk said she would check the paperwork that had been received from Essex Highways.

141-18/19 Street Lighting

Lights in East Hanningfield Road at the Wheatsheaf end have been reported.

Cllr Hart said the light next to the hall in Battlesbridge was out. The Clerk said she would report this to the contractor.

142-18/19 Reports from Councillors on Council activities undertaken since the meeting held on 30th October 2018.

Cllr Cheater said he had reported a shed dumped on Sonters Down which had now been removed.

He said he had spoken to an officer at Essex County Council who had confirmed that the Parish Council could have sought three different quotes for the gateways and had the work completed for less cost.

The Chairman said this would be clarified once the position regarding the trustees was resolved.
