205-17/18 Apologies and Reasons for Absence

Apologies were received and accepted from Cllr Cheater and Cllr Millane.

206-17/18 Declarations of Interest on Items on the Agenda

Cllr Chapman declared a non-pecuniary interest in Items

207-17/18 Public Forum – strictly 5 minutes only per speaker

Residents of Hayes Country Park raised the issue of the refusal of the appeal. They said the razing of the club to the ground, which would be the result, would be a huge loss to the Park. Residents said they would like an end to the building work, and to feel settled. They asked for help from the Parish Council.

Cllr Ride said he would do all he could to support the residents as ward councillor, and he hoped the Parish Council would also support them.

A resident asked if the Council could consider holding a Parish Meeting to discuss the answers to the questions asked at the Parish Meeting held in December, with Cllr Chapman as Chair.

The Chairman said the Council would consider this suggestion.

A resident raised the issues of flooding in Hoe Lane and the streetlights.

Cllr Ride said that Chelmsford City Council's Development Policy Committee had met on 18th January 2018 to discuss the Chelmsford Local Plan consultation. He said Rettendon had not been identified for large-scale development but that there were over 1,000 new dwellings planned for the South Woodham Ferrers area. He said there would be implications for the A132 and that the Parish Council was already pursuing a safer crossing for Hayes Farm residents. He said residents should look at the submission and make comments.

He said he and Cllr Millane would probably begin surgeries in February.

Cllr D Fleming said the streetlight on Maltings Road had been fixed.

Cllr Hart raised the issue of South View Road and the chicanes. He said he would bring both items to the next meeting.
