# Funds allocated to improve infrastructure in the city

Chelmsford City Council has allocated over £10 million to support the delivery of new infrastructure, using funding secured via development that is taking place in the City.

The funding is being directed to a range of projects including sports facilities, parks and open spaces, flood protection, health care, public realm and highway improvements and affordable housing.

**Riverside Ice and Leisure** Centre is to receive £2.4 million towards supporting construction of the new leisure facility. The funding includes £745,000 for public realm and cycle way improvements to enhance the riverside through boardwalk and balustrade lighting, as well as to improve security, trees, riverbank works, paving and a cycle shelter and cycle hoops. This will see the riverside walk transformed

from its access at Victoria Road up to Prezzo and Loch Fyne where it meets Bond Street.

Other projects receiving funding include further public realm enhancements in the City Centre, enhancements to GP surgeries, 58 projects to enhance the City's parks and open spaces, flood protection, local highway schemes and the new Family Hub in the Central Library.

Elsewhere in the City Centre further improvements on the north side of the train station will soon be underway to create improved pedestrian, cycling and circulation space between the station, the Marconi Evolution site and Anglia Ruskin University, where the new School of Medicine is now under construction.

A £15 million package of cycling, public transport and highway improvements across Chelmsford has recently been the subject of an Essex County Council consultation exercise and the prioritisation of schemes to be delivered is now underway.

Infrastructure provision continues to be a priority for Chelmsford and the Council, working with Essex County Council, has submitted a number of bids to the Government to seek additional investment as Chelmsford continues to grow.

## **Chelmsford's Business Improvement District**

A group of businesses in Chelmsford City Centre have begun work on proposals for a Business Improvement District ("BID"), building a positive vision of how businesses can work together to address trading concerns and cement Chelmsford as the county's premier retail and leisure destination. The BID could begin operating from April 2018.



BIDs are widely used across the UK with over 200 successfully in operation, including in Cambridge, Ipswich and Norwich. They are used to enhance the management of city centres, allowing the businesses within their area to shape and direct this to meet local objectives. This is paid for by a small levy on business premises, likely to be 1.5% of rateable value.

Importantly, BIDs supplement rather than substitute council services – their name can be misleading since they are often used to further evolve successful locations rather than being a means of regenerating underperforming ones. Perhaps the most visible example of this is The New West End Company BID covering London's West End.

Chelmsford's BID has come about following the successful opening of the Bond Street shopping development in 2016 and the subsequent rejuvenation of the city as a retail and leisure destination. Consequently, there is an emerging belief that the city centre requires more intensive management, beyond the statutory duties of the council, so that it meets the aspirations of its wider catchment and fulfils its recently acquired City status.

Over the summer, face to face surveys were carried out with over 90 businesses and other stakeholders in the City Centre and a positive response was received to the idea of a Business Improvement District. A steering group is now formulating a business plan focussing on identified key issues: marketing and promotion, events, anti-social behaviour, cleanliness and public realm. This will be presented to businesses in the city centre with voting expected in February.

## Chelmsford's new Local Plan

The Council's new Local Plan is progressing well, with the final version due to be published for consultation early in the New Year.

The Local Plan identifies the number and locations for houses, jobs and businesses we are planning for, along with other things needed to support growth, such as where children will go to school, where people will work, and how they will get around. It also includes draft planning policies which, when adopted, will be used to determine planning applications. The Proposals Map shows where particular policies apply.

Following consultation on

the Local Plan – Preferred Options in the spring, nearly 2,800 comments were received from more than 1,600 people and organisations and have been summarised to help produce the final version of the Local Plan. The summaries can be read in our feedback report, published on the Local Plan webpage at www.chelmsford.gov.uk/pr eferred-options

Other work to inform the document is also being finalised, including junction

modelling to look at highway capacity, viability assessment of the whole plan to make sure it is deliverable, a more detailed assessment of proposed sites in areas of flood risk, and a study to make sure the Plan meets green infrastructure needs.

## Chelmsford City Growth Package



Essex County Council has secured £15m to invest in a series of transport improvements around the City of Chelmsford. The investment is called the 'Chelmsford City Growth Package', and has a focus on sustainable transport options in order to support future housing and job growth, with highways improvements to tackle congestion hotspots. The Chelmsford City Growth Package identifies 29 proposed schemes across the Chelmsford urban area. The schemes have been split into five areas:

- North Chelmsford
- West Chelmsford
- Chelmsford City Centre
- Parkway Corridor
- South and East Chelmsford

In addition, city-wide signage and technology improvements have also been identified.

Throughout July and August, Essex County Council undertook a consultation exercise to gain feedback on the proposals outlined in the Chelmsford City Growth Package. The consultation closed on 28 August, with nearly 1,000 responses from individuals, businesses, local authorities and other organisations. Consultation responses are currently being examined in depth to understand the views of respondents on the proposed schemes. This review will be used, alongside other information, to decide which schemes will be included in the final business case for funding, due to be submitted to South East Local Enterprise Partnership (SELEP) later this year.


## Chelmsford: a great opportunity



The Marconi Room can hold up to 60 people whilst the Crompton Room holds 30 people in a theatre style.



## Grants and advice available

A significant number of grants and unrivalled advice from experts is currently available to businesses to help them develop, grow and save energy costs. Whether a start-up business or one that is already established, particularly Small and Medium Enterprises (SMEs) can qualify for many of the following schemes. Several schemes are also applicable to charities.

#### **Business Innovation Vouchers**

University of Essex - Support available: Grants up to £5,000. Offering Innovation vouchers to provide funding for SMEs to engage with universities, with the opportunity to foster long-term partnerships.

#### Essex Growth Programme

Backed by the European Regional Development Fund, the programme helps individuals establish new businesses and helps existing businesses to grow through advice and a capital grant programme: 20% intervention rate of up to £20,000

#### Food Processing Grants / Rural Tourism Infrastructure / Rural Business Development

Support available: Grants between £50,000 and £1,000,000. All the Open Rolling Calls close on 31st January 2018.

#### Get Exporting 2 Programme

Support available: Grants up to £3,000. Get Exporting 2 is a tailored programme of advice and assistance, both financial and 1-2-1, to enable companies to begin selling overseas or to expand internationally thereby increasing profitability and employment in a sustainable way.

#### Grants for the Arts

Support available: Grants between £1,000 and £100,000. Grants for the Arts has been designed to encourage applicants to develop ideas linked to artistic needs and future plans. It aims to be flexible and to encourage new ideas.

#### KEEP+

A European Regional Development (ERDF) Funded programme supporting SMEs to access knowledge and expertise through collaboration with universities and research institutions.

#### LEADER Support

(particularly Essex Rivers Local Action Group covering Chelmsford rural area): Grants of up to 40% available to grow economic activity in rural areas. Minimum grant amount of £10,000. LEADER is part of the Rural Development Programme for England (RDPE) which provides funding to rural businesses and communities (see p11).

#### Low carbon across the south east (LoCASE)

Support available: Grants between £1,000 and £10,000. Helps businesses work in ways that are environmentallyfriendly, with low carbon emissions, and make the best use of resources (see p12).

#### Manufacturing Growth Programme

The Manufacturing Growth Programme (MGP) provides free advice and grant support to manufacturing businesses to support the implementation of a growth plan. Grants available at 35% intervention rate.

#### South East Business Boost (SEBB)

Support available: Grants between £1,000 and £10,000. Capital grants at 30% intervention rate are available to support businesses in the SELEP region to grow. Free business advice is also available for SMEs and start-up companies.

#### The Prince's Trust

Support available: Grants between £1 and £3,000. The aim of the Trust is to provide practical and financial support to young people in the UK that are not in work, education or training. The scheme helps develop key skills, confidence and motivation, enabling young people to move into work, education or training. The maximum grant assistance available is £3,000 although this varies by programme. Loans of up to £5,000 are also available.

## Essex Rivers LEADER funds a Robocrop, Passenger Boat and <u>Nursery</u>

Three local organisations have recently received a cash boost from the EU LEADER grant in the Essex area to enable them to increase their staff and expand their organisations.



#### Tillingham Hall Farms (Sarah Greens Organics)

has received a grant of £23,000 towards a Robocrop which is an innovative, cameraauided robotic weeder which will allow the high speed and economic weed control of the existing farm's organic vegetable crops. This will ultimately lead to more reliable production and improve the viability of the farm. It will also allow the farm to increase the vegetable growing area by 4.53ha to a total of 21.86ha and take on a further 2 full time staff.

#### **Essex Waterways**

is a local charity which has received £33,000 towards the purchase of Victoria, a passenger boat on the Chelmer & Blackwater Navigation, based at Paper Mill Lock. The boat was built specifically for this waterway and was about to be sold. Essex Waterways saw the potential for an income stream for the charity and were successful in being awarded a grant for the project.

#### Jesters Integrated Childcare

is based in Bicknacre and the owner has been running a very successful after school club for the past 16 years. She is now opening a nursery and has received a grant of £88,000 to help her achieve this. The Essex Rivers Local Action Group has been set up to distribute £1.8million of LEADER funding to rural businesses and organisations in parts of Essex. The aim of the EU grant is to help boost growth and create jobs in the countryside and the group is made up of local community representatives from rural businesses and public bodies.

Robert Davidson, Chairman of the Essex Rivers Local Action Group and a local farmer, said: "We were delighted to be able to support these three projects by granting this money. They are very diverse projects and illustrate the wonderful mix of businesses we have in Essex." "This is great news for the rural economy in Essex and all projects will lead to more jobs and a boost to each community."

Beverly Davies, LEADER Programme Manager, added:

"You don't have to be a business to apply; if you are a farmer, smallholder, forester or are involved in local tourism, you may be eligible for a grant. Just contact me and I will let you know if you are eligible to apply for money for your project. We still have grant to give out and are looking for new applications."

The LoCASE project goes from strength to strength with over £1.7 million in grants approved since February 2016!

From air-conditioning, PR, marketing & IT, to refrigeration, new LED lighting and so much more...the LoCASE project is here to help maximise your business potential!

#### Two Chelmsford Successes!

EPC Improvements provide advice & solutions to improve property energy efficiency through access to government grants, meeting the "Minimum Energy Efficiency Standard Regulations" (MEES).

New regulations will soon make it unlawful to let buildings in England and Wales below a minimum Energy Performance Certificate (EPC) "E2" rating. A LoCASE grant of £10,000 helped to fund a campaign on Phoenix Radio raising awareness of the regulations, and a social media / search engine /online campaign, helped to raise their profile and grow their business!

Intelliconnect designs and manufactures components and connectors for the defence industry along with connectors for water monitoring companies.

Receiving a LoCASE grant of over £2,300 enabled the purchase of a second Solidworks license (3D CAD Software) reducing training visits to the Corby based manufacturing facility. Expected savings will be; 4.29 tonnes of CO2e, 14,300 miles of road travel (273 tonne.km) - resulting in savings of over £4,000 pa.

Reduced emissions by companies engaged with the LoCASE project amounts to thousands of tonnes saved per annum, with savings of thousands of pounds on energy bills, and business in the low carbon sector are achieving their growth potential.

For small/medium sized businesses looking to save money on overheads, or offering low carbon goods or services, grants of up to £10,000 are available right now!

The Low Carbon Across the South East project, part funded by the European Regional Development Fund (ERDF), aims to support SMEs across the South East Local Enterprise Partnership (SELEP) region, to improve their energy efficiency.

## Happy First Birthday Bond Street!

On Saturday 30th September Bond Street Chelmsford celebrated its full day of activities and offers to keep shoppers a dramatic parade through the High Street, the entertainment then moved into The Bond Street Bowl events space. The annual Skills Evidence Base, first launched in 2014, has been refreshed for 2017 and is expected to be used as a valuable tool in shaping the skills system and closing vital skills gaps in some of Essex's key growth industries.



Developed by the Essex Employment and Skills Board (ESB), a strategic group formed of employers across Essex, Southend-On-Sea and Thurrock, the Skills Evidence Base consists of profiles on all 14 districts and seven key sector profiles including:

This year, there were 84,500 job vacancies in these seven sectors alone.
