Emergency? ALWAYS use 999

Fly-tipping is a CRIME—let's fight it

Dumping a bit of litter? In a ditch down a remote lane? Anything from a plastic bag of rubbish, a mattress, an old 'fridge—or a pile of rubble or scrap: it's a crime by any standard. It's dangerous to people, livestock, and wildlife. It's an eyesore. It encourages vermin and disease. It can block traffic—people trying to get to work or going home, children going to and from school, emergency vehicles. It costs money to dispose of this junk—either from the local authority, that would be used for other hard-pressed services, or out of the pockets of private citizens. We all have a duty of care to ensure that any unwanted

material is disposed of in a responsible way, and this includes when we engage individuals or companies to carry out work for us, like builders, gardeners, tree surgeons, house-clearers, or scrap metal merchants.

Waste and the Householder's Duty of Care

Chelmsford City Council has produced guidance to householders on the engagement of contractors who would dispose of waste on your behalf: and all such people will normally need to be registered to carry waste. There are unscrupulous waste carriers who have charged householders for taking waste away only to dump it in a lay-by. *These traders rely on householders not asking questions as to whether or not they are registered to carry and dispose of waste.* However, the legal responsibility falls to the householder to check they are registered. This means that *if you pay someone to take material away from your house and then they dump it (fly tipping), you* ►

► could be fined up to £5,000 if it can be proved it came from your house or garden.

Steps householders should take to take when arranging for any waste to be collected, other than through the Council

To avoid running into problems, follow this advice from the City Council:

- Ask the contractor if they are a Registered Waste Carrier - and ask for their registration number.
- Check their details with the Environment Agency on telephone number 08708 506506, or online at www.environment-agency.gov.uk/publicregister. If the contractor is not registered you are advised to decline their services.
- Record your contractor's details—their name, address and telephone number along with the registration number of their vehicle
- Keep details of the contractor, for example their calling card, a copy of their newspaper advert and their receipt for payment for work.

The **Duty of Care** aims to protect people and the environment. If householders only use legitimate contractors, they can be satisfied that their waste will be disposed of lawfully. Rogue traders will lose custom, and then be forced to act within the law, or cease trading.

Councillor Ian Grundy, City Council Cabinet Member for Safer Communities says, “Everyone has a duty of care for the rubbish they produce. The majority of residents go out of their way to keep Chelmsford clean and green and dispose of waste correctly—but a few spoil it at the expense of others and our environment. We will target the few selfish people who fail to dispose of their waste responsibly and enforce this duty of care through legal action.”

If you witness someone in the act of fly-tipping you should dial 999 as the person doing the tipping is potentially endangering the community and the environment. Without putting yourself at risk, take details of the vehicle, person, location etc., but **do not approach the tipper at anytime, and report it.**

Essex Police encourage members of the public to report non-emergency matters to them—and other services—by doing it online. Their web link is

This link provides access to a range of police and other services, as shown below (and elsewhere in this newsletter). The police also encourage members of the public to provide non-emergency information—anononymously if you like—on suspicious or worrying activities you might see.



Inspector Andy Sawyer, Chelmsford's Community Policing Team leader, says Neighbourhood Watch members (and the public in general) “should make use of the ‘Do it Online’ facility on our website—just Google ‘Essex Police’ and follow the links. Information can be left on the **Crimestoppers** link as they log everything and everything then goes to the relevant police service. In high profile or some particular cases of interest, we do then get approached by **Crimestoppers** to confirm we've acted on the information (and asked what we've done). Clearly there is nothing stopping Neighbourhood Watch members or any member of the public from still calling 101 or 999 as appropriate, or going direct to the **Crimestoppers** website.”

In previous newsletters we have pressed the need to be vigilant against fraud—by telephone, Internet (including email), by post, and by people knocking on your door; then there's 'plastic card' fraud—stolen credit and debit cards being put to criminal use; and stolen user names and passwords with online bank accounts, Paypal™ accounts, online shopping, and so on. Online fraud is now the most common crime in the UK, with almost one in ten people being victim, and more than five and a half million related offences taking place each year. So we make no apology for keeping on about this scourge.

- NEVER give pin numbers or passwords out over the phone or on-line;
- BE VERY CAUTIOUS about clicking a link in an email—NEVER is safest;
- BEWARE of look-alike websites—even websites that are 'legitimate' businesses can charge a hefty fee for an otherwise free service from, for example, HM Government: a legitimate government website will have **gov.uk** in its web address.
