#### 21/048 Dist Cllr's Report

- The new Independent Administration at MDC agreed to increase the council tax by the maximum allowed. This was not supported by all members.
- 2. Some costs including the Thames Barge mooring fees had been reduced significantly.
- 3. Given some complaints regarding missed collections residents were reminded to present their waste and recycling before 7am on the appropriate day of collection.
- 4. The situation regarding waste collections in Old Heath and the condition of the roads was being considered by MDC and Suez.
- 5. As part of the initiative to support local businesses in Maldon some free parking sessions were being offered in the High Street car parks during April. Check local press and MDC website for more details.
- 6. The Council Offices would re-open in accordance with the Government guidelines
- 7. It was anticipated that the splash park would open in July
- 8. EFRS were looking to recruit retained fire fighters (Details on MDC website)
- 9. Free smoke alarm tests and replacement alarms were being offered by EFRS (Details on the MDC) website.
- 10. PC&FC, County and some District by-elections Elections were taking place on 6<sup>th</sup> May (there is lots of time left to register for postal votes)
- 11. The legislation for holding virtual meetings expires on the 6<sup>th</sup> May. The Government are considering options to allow for remote participation. MDC will debate the issue this Thursday/
- 12. The Statutory Annual General Meeting of MDC will take place on 20<sup>th</sup> May.

Cllr Pratt commented that he supported the efforts of Dist Cllr Fluker in speaking to Suez regarding Old Heath Road, Cllr Pratt commented that if the vehicles went slower, they would be able to achieve the refuge collections.

#### 21/049 Proposed new building at King George V Memorial Field

Update from Cllr Anderson and Cllr Harrold.

Cllr Anderson informed that Fields in Trust have now agreed to a new two storey community building subject to planning permission. Cllr Anderson will now go out to tender for three quotes for design.

Cllr Anderson and Cllr Harrold are to attend a bid seminar on 24th March 2021.

#### 21/050 Jubilee Woods

Cllr Harrold to update.

Cllr Harrold informed that Jubilee Woods is very wet at the moment, the ditch will also needed to be looked at, as it is still quite full. The contractor will cut back the trees later in the season when the weather conditions improve. Wood Actually, suppliers of the carved figurines will supply in early June to allow for the concrete pillars to be placed.

#### 21/051 Free Trees for Planting projects

Would Members like to apply for a minimum of 200 free trees from eforests?, the trees are all native UK species and can be supplied with free shelters, stakes, weed mats etc.

Members decided that the minimum amount that could be applied for was too many, so will not apply for this offer.

Cllr Wyn-Davies proposed the Christmas Light switch on to be held on Sunday 28<sup>th</sup> November 2021 @ 5pm, all agreed.

Members discussed the previously circulated details of proposed Christmas lights for 2022 – 2024, Cllr Bridge commented that the current lights Southminster has are good value.

Cllr Pratt proposed for 2022 – 2024 keeping to the same lights as are provided currently, seconded by Cllr Anderson, all in favour.

#### 21/054 Community Engagement Team

To discuss and agree Request for Service, April 2021 – March 2022.

Nicola Syder and Pat Mackshea held a brief question and answer at the beginning of the meeting with the Councillor's.

Cllr Pratt commented that he was very disappointed with the question-andanswer session. Cllr Pratt proposed asking the Community Engagement Team to make a proposal with intentions to Southminster Parish Council with a review to take place in three months, this was seconded by Cllr Mische. The Clerk will write to the Community Engagement Team to ask for a proposal with intentions.

Cllr Noonan commented that you cannot predict timescales for anti-social behaviour. Cllr Wyn-Davies asked what would happen if the team didn't give presence in the village, Cllr Pratt responded they are the specialists, they need to come back with an achievable proposal in the form of a three-month

service level agreement. It was commented that better youth engagement is needed.

#### 21/055 Ormistan Rivers Academy

To discuss and agree formal response to the consultation on proposed expansion of Ormistan Rivers Academy.

Cllr Bridge proposed that Southminster Parish Council respond in agreement to the proposed increase in class expansion, seconded by Cllr Pratt.

Cllr Harrold commented that all infrastructure needs to be addressed, not just the schools.

A short discussion took place regarding pot holes, Cllr Pratt informed that there is a big programme for pot hole repairs in process, however the same work force have also been gritting the roads which has created a backlog.
