21/078 Dist Cllr's Report

Firstly can I congratulate Cllrs Anderson and Harrod on their re-election and that said I look forward to working with them the clerk and the Council for the ensuing Municipal Year

The Council Offices are still closed but in exceptional circumstances it is possible to meet with offices subject to booking an appointment in advance.

Due to the District Council By-Elections the council is currently operating under the rules of Purdah

'Click it Local' which supports local independent retailers has launched on the MDC website

Applications are invited from small and medium sized businesses, who may have previously fallen outside the scope of central Government Covid-19 for financial support.

MDC are administrating the governments self-isolation payment scheme. Subject to the criteria being met grants up to £500 are available.

Polling Day 6th May - Polling Stations throughout the district will be implementing a 'Safe Voting' process which will mean all polling stations will be Covid compliant. Voters unless medically exempt will be required to wear a face covering whilst in the polling station. Although they will be provided to reduce the chance of transmission voters are advised to bring their own pen/pencil

Self-test kits are available from the local chemists and libraries or online via the Governments own website.

I have received several complaints from people living in the north of village regarding the noise from the Commercial Clay Pigeon shoot which takes place at Asheldham on Saturday mornings. If you or any one you know is affected by the noise nuisance then contact David Cant the Environmental Health Officer at MDC. I have received several complaints regarding the roads around the Kings Road development - Officers from MDC have visited the site as a result.

MDC is holding an extraordinary meeting this Thursday. The council will decide next steps following the ending of the Coronavirus Regulations. The Council Offices are unsuitable to hold covid compliant Council meetings alternative venues are being considered and an announcement will be made following the meeting. The next meeting of Maldon District Council will be the Statutory Annual Meeting on 20th May. The meeting will be held face to face at a venue and time to be confirmed. The meeting will be live streamed.

Cllr Harrold informed that the contractor appointed to undertake maintenance/clear dead trees has started work and is currently ahead of schedule.

The Clerk informed that a Micro Grant application to the Community Initiatives Fund has been successful, a grant of £460 has been awarded for a Buddy/Reflection Bench.

Cllr Mische will gather costings for a litter bin, the Clerk will agenda for next meeting. Cllr Harrold will liaise with Appletons/MDC to organise the positioning of a new dog waste bin.
