Minutes

The meeting of Southminster Parish Council held at Community Hall1, King George V Memorial Field, Station Road, Southminster on the 16th September 2019 at 19.30 hrs.

19/174 Apologies for absence.

19/175 To receive and approve Minutes of the last meeting – 16th July 2019 and Extra

Ordinary Meeting 29th August 2019.

16th July 2019 Proposed by Cllr Pratt, Seconded by Cllr Noonan.

19/176 Matters arising from last meeting

EOM 29-8-2019 Cllr Pratt enquired if Knightswood had taken up the offer of the Car Park shop for rental. Knightswood Trustees are holding a meeting tonight and will

contact the Clerk this week to update.

19/178 Public Session – opportunity for members of public to speak:

A parishioner enquired if more open public swims could be made available by Southminster Swimming Pool as opposed to just classes, perhaps a Saturday morning fun session to run throughout the year. A suggestion was made regarding Hatblock funding, it was felt that this maybe an option. It was commented that SW Swimming would need three lifeguards, suggestion to look for funding and agenda for a future meeting. A meeting is in the process of being arranged with Cllr Anderson, Cllr Harrold and Southminster Primary School.

A parishioner enquired when roadside hedges will be cut, Cllr Anderson informed that hedgerows are usually cut in September due to birds nesting. It was commented that hedgerows on Scotts Hill were not maintained last winter.

A parishioner raised concerns regarding construction vehicles at 1 Kings Road, Southminster, they are parking on the grass near the Southminster sign and also on Kings Road, can they park within the construction site itself?, Cllr Anderson informed

he did not feel it was a matter Southminster Parish Council could resolve. It was commented that workers are on site between 7.30am – 6m weekdays, but should be 8am – 6pm weekdays and 8am – 1pm Saturdays. The public felt it was very dangerous crossing by 1 Kings Road due to the vehicles.

The footpath in Seasons Wood has always been cleared by Highways, not FOSCOS, Cllr Anderson informed there is a Highways meeting shortly.

It was commented that weeds are pushing through the tarmac on the new Pantile Hill footpath.

Southminster Parish Council have recently supported a planning application in Queen Street, the public wanted to know why? Parishioners felt that supporting the application was the issue and that no reasons were given for supporting the application. Cllr Harrold explained that Southminster Parish Council can only support or recommend refusal.

A Parishioner enquired if Moat Housing at Kings Road can be made available to local people, Cllr Pratt informed this was not a planning condition.

19/181 Dist Cllr's Report

Application to build 140 houses at New Moor Farm Southminster

This application could have impacted on the infrastructure of Southminster including Roads, Schools and Doctor Surgeries after significant lobbying by interested parties and myself as the ward member for Southminster the application has now been refused by Officers at Maldon District Council

MOG Meeting Maldon Operational Group (New Health facility at Maldon)

The Group of which I am a member met last week – NHS England have provided funding to the local CCG to conduct a feasibility study and needs assessments which includes indicative designs of a new facility

The CCG is now negotiating with two landowners in Maldon

The facility will initially act as a super health hub but will eventually take on all of the facilities offered by the Current St Peters Hospital along with other service areas provided by Broomfield and Basildon Hospitals.

The Blackwater Reach development at Southminster is well under way – there is a reserved site for a medical centre off David Fisher Way – the landowners, CCG, NHS England and the local Doctors Surgery are currently working towards delivering the scheme

Local Development Plan

The council still has a 5-year housing land supply and the recognised number of new dwellings being delivered is meeting the targets set by the LDP. As result the District Council will contest all speculative developments that do not comply with policy.

The Council has agreed not to defend the appeal of the strategic site known as North Heybridge Suburb which comprises of 1330 properties. The new application is being reconsidered this Thursday if agreed it will further bolster the Councils 5 year land supply which will help to prevent speculative developments in the District.

Full Council Transformation

Maldon District Council is nearing the completion of its transformation process which will result in savings of £1.8m per annum - this process has been necessary to fill funding gaps and ensure the future sustainability of the Council – The council has still not submitted its accounts these are due to be delivered by the end of October.

Council Offices

Maldon District Council is considering moving its offices. The current offices are larger than the Council needs and are disproportionate in value. The buildings are not environmentally friendly, the cost of running the buildings is c£500k per annum. It is anticipated that the new offices will remain in Maldon. Any surplus generated through relocation will be invested in social projects.

20 MPH Speed Limits

Several Councils have contacted me with regards to the initiative of reducing speed limits to 20mph in villages throughout the District. I have written to the Deputy Leader of ECC who is responsible for highways asking him to back our initiative.

MDC had set up two working Groups Bradwell A – to deal with the Care and Maintenance and Bradwell B to deal with the new powers Station

JMBB

The Joint Members Bradwell B Board – I am a member of the Board and will work to ensure that residents are properly protected during the construction phase and that wherever possible local jobs will go to local people first

Commercial Manager

The Council has appointed a Commercial manager the post holder will be responsible for delivering £750k of commercial income over the next four years

New Constitution

The Council approved its new constitution at its meeting last Thursday

Southminster List of Local Heritage Assets

The List of Local Heritage Assets for Southminster have been adopted by MDC

Brexit Preparations

MDC is part of the Eastern Region planning group the Council has involved in the regional risk Matrix and is considering potential risks on a daily basis

19/182 Local Highways Panel

Scheme suggestions to be submitted for consideration at Local Highways Panel.

Cllr Pratt informed Old Heath Residents Group have asked for the Councils support regarding speed control, they have already asked Local Highways Panel for support. Cllr Pratt lives in Old Heath.

Cllr Bridge asked that Cllr Pratt keeps an eye on what is happening with the Army and Navy flyover.

Cllr Anderson suggested a one way system in Queen Street and North Street, Cllr Bridge suggested a survey to see how Parishioners felt about the suggestion. Parishioners suggested 20mph throughout the village.

A suggestion of the speed camera being placed at the top of Kings Road was made. The police have removed the allocated Trucam location from the High Street.

19/183 Allotments

Would Councillor's like to subscribe to The National Allotments Society at a cost of £55 plus vat per year.

Cllr Pratt proposed joining The National Allotments Society, seconded by Cllr Noonan.

19/184 Allotments Land Registry

The allotments have not been registered with Land Registry. Would Members like to place this with Kew Law Solicitors to carry out or prefer the Clerk to investigate? It was proposed by Cllr Harrold to instruct Kew Law Solicitors to complete the registry, seconded by Cllr.Noonan.

Cllr Harrold to give an update and to ask for volunteers to assist with the event, All 1000 Wristbands have been ordered for the event, names and addresses will be taken when handing out the wristbands to residents, it is hoped Southminster Primary School will help with wristband allocation

All Councilors have volunteered to help.

Cllr Harrold informed Mr Brad Luff is assisting the Council with the Risk Assessment. Cllr Harrold has liaised with all interested parties, children's entertainer, food stalls, pub and fireworks. 5 Community Protection Officers will be in attendance.

David Wilson homes have donated £500 to the event.

A local estate agent is willing to sponsor the event as well, they are looking for a minimum of 20 advertising boards around the village, names and address will be taken of anyone offering to have a board at their property.

It is hoped that should the event run smoothly and be a success, that it may be extended to next year.

Cllr Harrold and the Clerk will order posters and banners for the event.
