Land West of Spratts Farm Queenborough Road Southminster Essex Southminster Parish Council OBJECT to this planning application for the following reasons:

The Parish Council refers you to Appeal Ref APP/X1545/W/24/3351697. The Land North of Homefield and West of Tillingham Road Southminster CM0 7DT The application site lies within a rural location outside of the defined settlement boundary of Southminster where policies of restraint apply. The site has not been identified by the Council for development to meet the future needs of the District and does not fall within a Garden Suburb or strategic allocation for growth. When viewed from the surrounding area including the local road network, footpaths, bridleways and nearby properties in Queenborough Road, Spells Close and Coombe Road the proposed development would substantially alter the character of the site and surrounding area and would have an unacceptable visual impact on the countryside through the urbanisation and domestication of the site. Furthermore, the application site by reason of its location and means of access would provide poor quality and limited access to sustainable and public means of transportation resulting in the occupiers of the site particularly those to the north being overly reliant on private means of transport. The limited benefits of the proposal do not outweigh the harm caused, and the proposal would therefore not amount to sustainable development. The Council understands that the local primary school and medical centre are at capacity and whilst it accepts that any objections from the Education and Health Care Authorities can be mitigated legally by financial contributions through s106 agreements the Council points out that both facilities are effectively landlocked and therefore cannot be expanded in any meaningful way. With regards the medical centre this would mean even longer waiting times for appointments The Council confirms that Queenborough Road at the proposed entry point to the site is very narrow effectively single track with limited visibility caused by the sweep of the bend and parked vehicles. The applicants own site plan identifies the narrowness of the road at this location. The junction of Queenborough Road with the High Street is very narrow and due to parked vehicles is effectively single track. The junction of Queenborough Road and North Street and North Street generally as a result of parked cars is single track. The junction North Street and High Street suffers from the same issues. Any additional traffic in these areas will exasperate the already difficult conditions that prevail. The parish Council specifically requests that rather than conducting a desk top survey the Highways Authority conducts an on-site survey at these locations and shares its findings with Southminster Parish Council. In summary the Council does not support the application on the basis of the harm caused to character and appearance of the area. The loss of amenity to neighbouring properties. The negative impact on the Southminster Medical Centre and Primary School and the negative impact on the highways network contrary to Policies S1, S2, S8 and D1 of the Local Plan and the NPPF.
