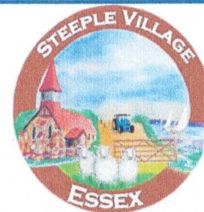

The speed watch team have undertaken many sessions with drivers speeding through the village
Cllr R. Wilson sent in a report. It read

I was invited as a team leader coordinator to Kelvedon Fire Headquarters where met the Fire chief and Adam Pipe who heads CSW along with Janey Wiley. There spent an hour showing us their vision and its called Vision Zero which is aiming at zero deaths on the road by 2040. As from this month the speed capture is being reduced (I cannot disclose the figure in writing) and I was presented a thank you award.

I have checked the 30mph sign on the street after Bates lane travelling West that luminates and confirm it does flash up at 34mph

Now working full time, I have tried to appoint a deputy to assist me but no one has come forward. We have been out a few times and every time normally capture around 12 vehicles an hour, though many more are speeding but below our allowance to record their speed to Essex Police. Our last session was only 35mins as was very hot and we captured 9 vehicles.

We do need more volunteers. I do have some advert leaflets, can we put an advert up at suggested places and maybe into next month's magazine? Any other suggestions?

Also caught 9 people in 35 minutes driving at more than 35mph. Plus 1 driver with no insurance
